**1. Agreement details:**

The Parties agree the following:

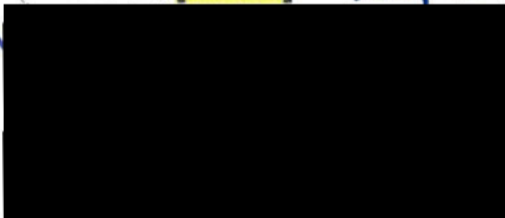

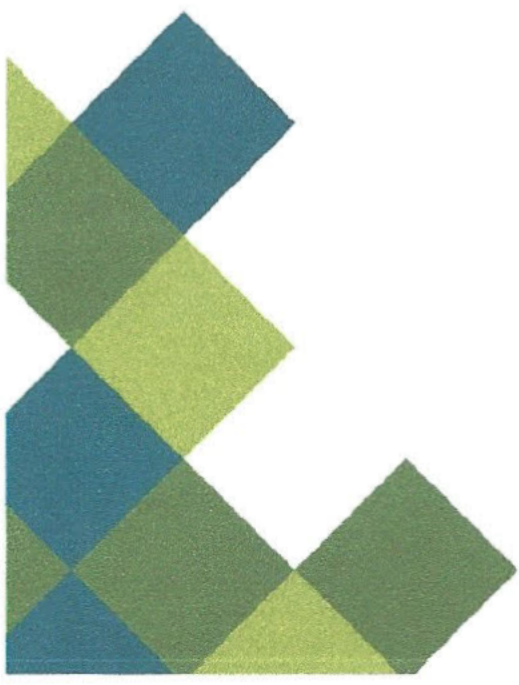
