Chief Executive Officer Overview

Welcome to the third *Quarterly Service Performance Report* for our *Council Plan 2021-2025*.

It has been a productive start to 2022 for Council, with a number of important projects and strategies progressing. With some easing of COVID-19 restrictions, many Council services have begun to return to normal conditions, with some minor disruptions due to staff shortages.

During this quarter there was a significant focus on community engagement, with Council seeking input and feedback on the *Community Engagement Strategy*, the *Housing Strategy*, the *Caulfield Structure Plan* and the *Smart City Roadmap*. These strategic documents will inform Council's decision making for many years to come, so it is pleasing to see a high level of engagement and interest from the community. Consultation and engagement will continue over the next quarter to ensure the views of all community members are well understood and reflected in our future planning.



The annual capital works program has been progressing well, despite delays in the construction industry due to COVID-19. Some of the key highlights and achievements include:

- The acquisition of three properties on Porter Road, Bentleigh for the purposes of future redevelopment into open space
- Completion of the new Aileen Avenue Park in Caulfield South which was officially opened on Wednesday 30 March 2022 by Hon. Lily D'Ambrosio MP
- Completion of a new nature-based play space at Rosanna Street Reserve, Carnegie
- Installation of a new exercise and fitness pod at Duncan MacKinnon Reserve.

In preparation for the state and federal elections in 2022, Council adopted a new *Advocacy Policy* and agreed advocacy priorities for 2022-2023. Our highest priorities for the coming year are to secure funding for the redevelopment of the Carnegie Memorial Swimming Pool and funding to help develop new open space for Glen Eira residents. Council has been working proactively to engage with all candidates in the upcoming federal election to promote its advocacy agenda.

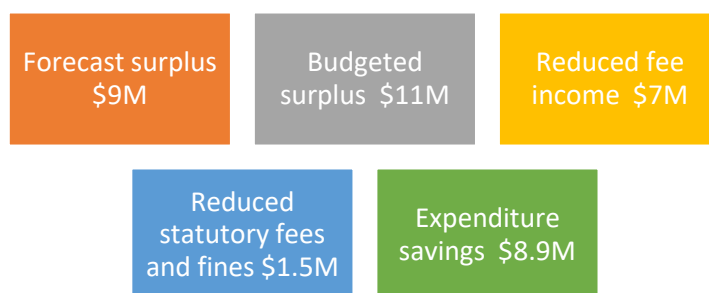
Financial Overview

2021-2022 began with further lockdowns that forced the closure of many council services and reduced our ability to raise income. In the third quarter most of our services have been able to reopen, and although our income streams continue to be affected there is a positive future outlook. The operating result year-to-date is lower than anticipated when the budget was set however the balance sheet position and the cash position remain favourable.

At the end of March 2022, the performance against budget from ordinary activities showed a favourable variance of \$4.5 million. This includes lower than anticipated income of \$6.5 million mainly due to the loss of user fees during service closures; and reduced expenditure - now \$11 million under budget. This is made up of savings where services could not be provided but also work delayed that will still need to occur when safe to do so.

The forecast result expected for the financial year is a surplus of \$9 million compared with the adopted 2021–22 Budget surplus of \$11 million. The decreased forecast result is attributed to reduced fee income (\$7 million); reduced statutory fees and fines (\$1.5 million); an asset write-off of \$2.66 million to enable new capital works to progress. The potential loss was partially offset by expenditure savings (\$8.9 million) mainly in employee costs.

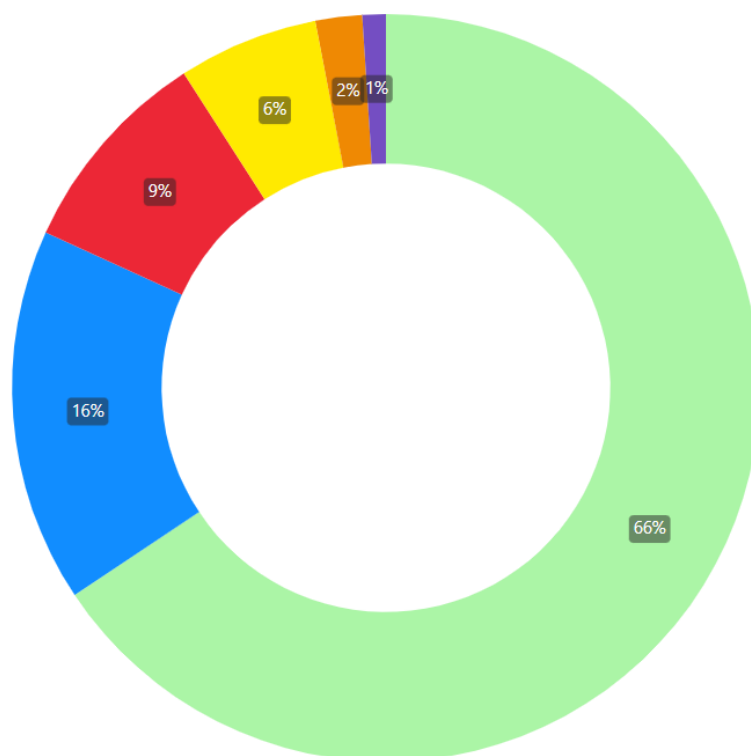
Council's forecast liquidity ratio, a measurement of our financial strength, is 0.98 against our budget of 0.94. This means for every \$1 of current liability, Council has 98 cents in current assets to meet those commitments. This position has been deemed a medium risk in the short term while we fund our strategic capital works projects.

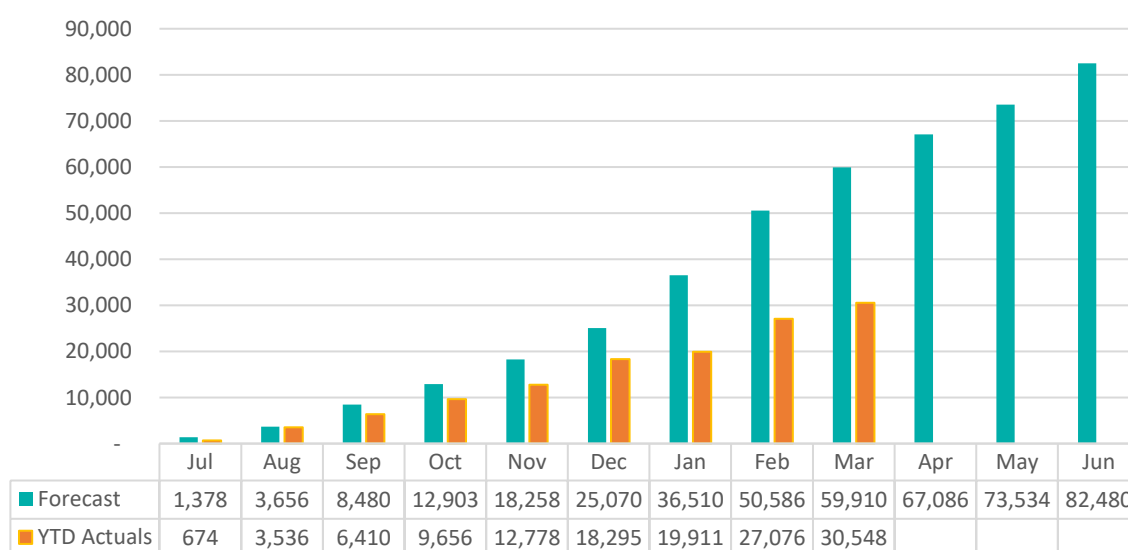

Capital Works Update

Projects Completed this Quarter:

Activity centre minor improvements program

This initiative incorporated upgrades, additions, refresh or enhancements within our activity centres including: laneway upgrades/rejuvenations, historical plaque celebrations, new street furniture and minor landscaping.

Duncan Mackinnon Reserve Community fitness facility and new shelters on netball courts

Tuesday 29 March 2022 saw the opening of a key feature of the Duncan MacKinnon Reserve Masterplan. This was the installation of a new exercise and fitness area in the south-east corner of the Reserve. The outdoor fitness pod features an impressive array of equipment including battle ropes, medicine balls, pull-up bars, step-up boxes, sit-up benches, as well as exercise bikes that connect to your smart phone by Bluetooth to race, track your progress and increase/decrease resistance. This project received State Government funding through a Sports and Recreation Victoria Grant of \$140,000.

All weather shelters were also installed between the netball courts for utilisation by coaches, players and spectators.

New open space Aileen Avenue

This is the conclusion of a project that began in the 2019-20 financial year. Further details on this project can be found in the project updates under strategic direction two.

Rosanna Street Reserve – Playground and landscape enhancement works

In addition to the upgrade of equipment, the play space has been extended to include nature play, a scooter loop with railway signage, new plantings, and a new shelter with a solar barbecue.

The Reserve was officially opened on Wednesday 30 March 2022. This project was made possible with the assistance of the Victorian Government through its Suburban Parks Grant, and the Federal Government through its Local Roads and Community Infrastructure Program.

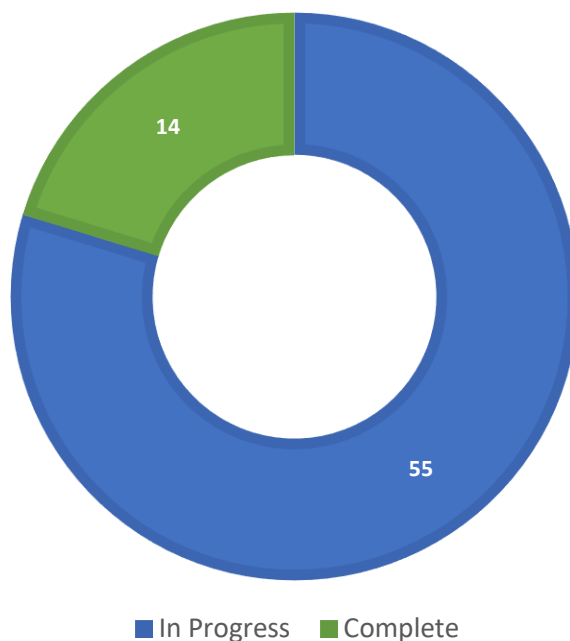


Progress of Council Action Plan

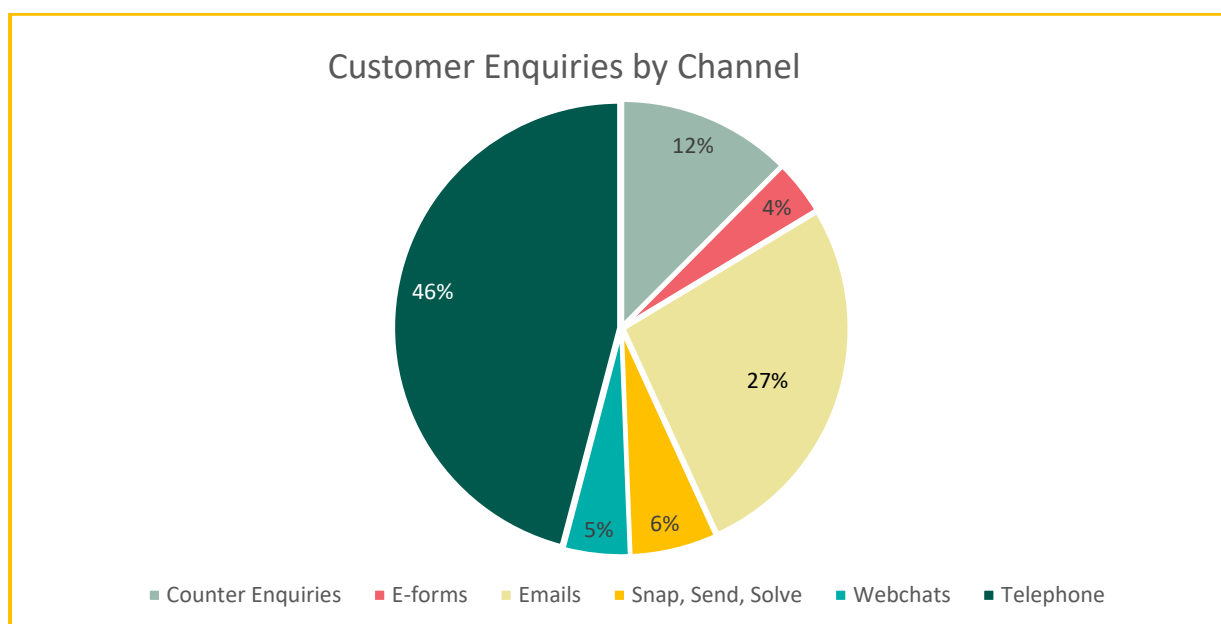
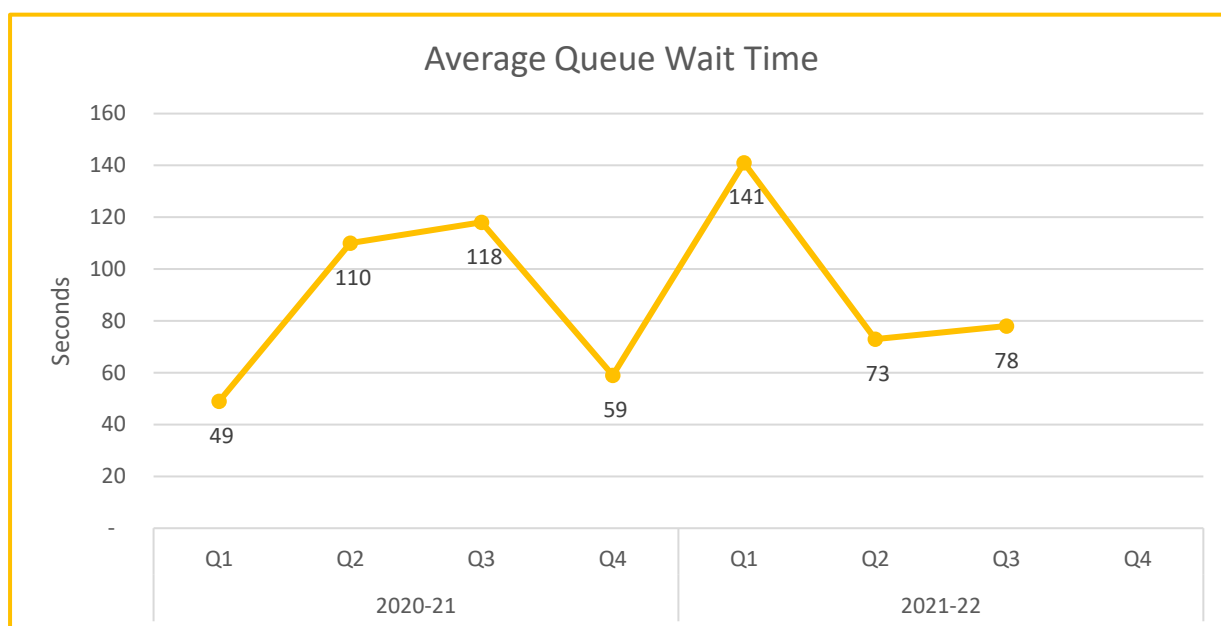

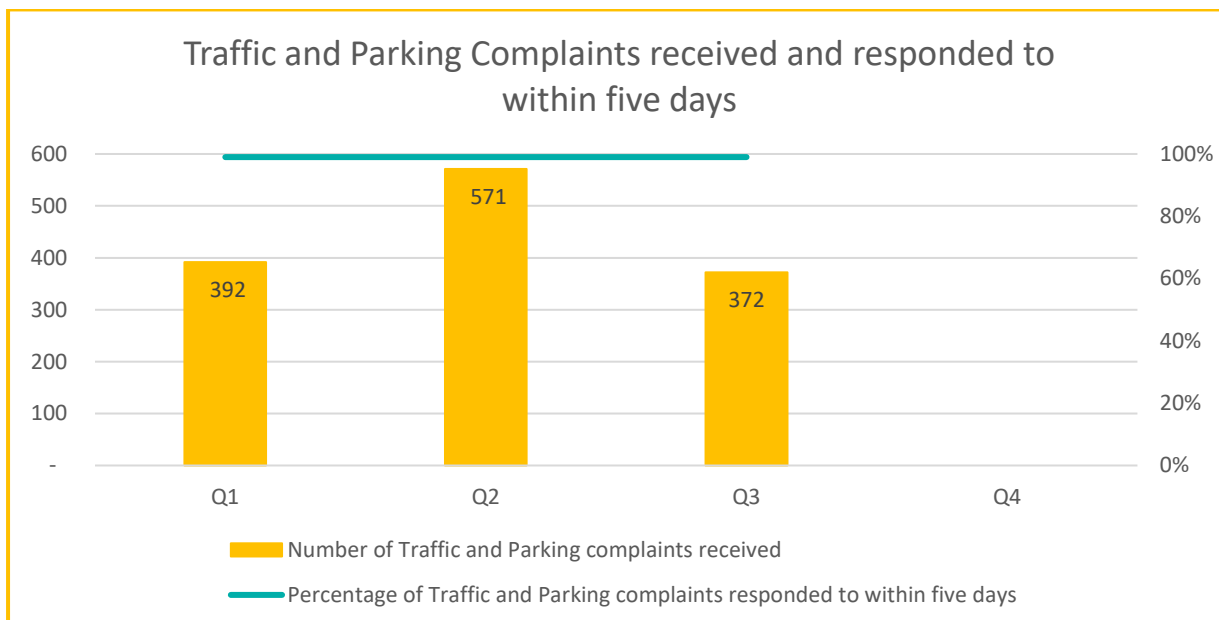

Customer Service

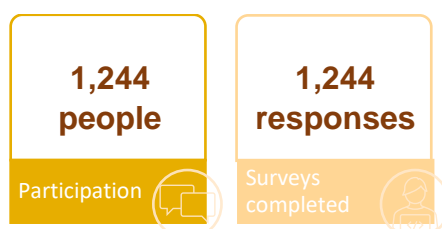
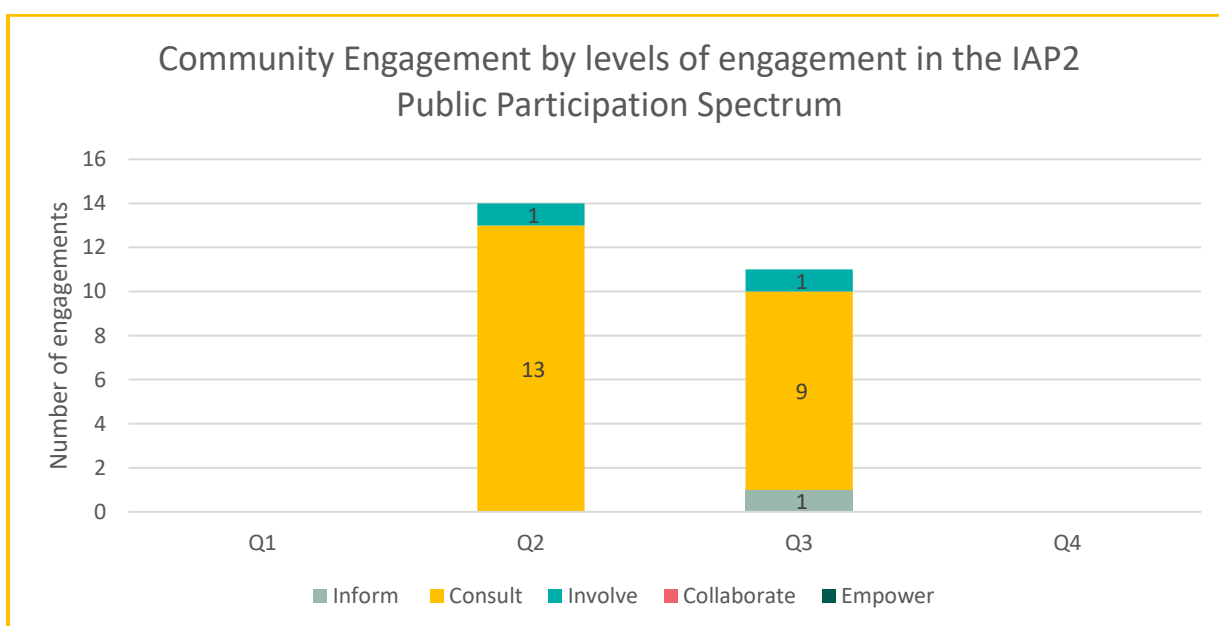


As part of the *Customer Experience Strategy 2020-2023*, we are committed to building better service experiences for our customers and community. To keep pace with evolving expectations, we have introduced a range of channels such as *Snap, Send, Solve* and the webchat functionality on our website, enabling customers to choose when and how to connect with us and access our services.

Since the introduction of these channels, the average queue wait time for calls to be answered has dropped.



The reduction in traffic and parking complaints received this quarter may be a result of people re-familiarising themselves with the traffic and parking rules. Council continues to respond to 99 per cent of complaints within five business days.



The *Community Engagement Strategy 2022-2026* aims to deliver on our promise to be open, transparent and inclusive in our engagement with the community.

As part of the *Strategy*, Council's approach to community engagement has been informed by public participation approaches outlined by the *International Association of Public Participation (IAP2)*.

The IAP2 Public Participation Spectrum articulates five levels of engagement, from very little influence (Inform) to the most influence (Empower) where the final decision is placed in the hands of the community.

A total of 11 community engagements were conducted this quarter. One on the 'Inform' level, where the community had the opportunity to provide feedback on the *Caulfield Village* development by means of a submission form, emailing or writing to us.

Nine engagements were conducted on a 'Consult' level. The community had the chance to have their say on projects such as the *Smart City Roadmap*, *Packer Park Playground* and *Draft Community Safety Plan* by completing online surveys, phone/video call, attending our drop-in sessions and writing to us.

The *Packer Park Playground Upgrade* community engagement was conducted on the 'Involve' level. Community feedback provided in the first phase of engagement was used to develop a concept design for the new playground. A second phase of community engagement was held from 4 February to 7 March 2022 to gain feedback on the concept design.

Inform: To provide the public with balanced and objective information to assist them in understanding the problem, alternatives, opportunities and/or solutions

Consult: To obtain public feedback on analysis alternatives and/or decisions

Involve: To work directly with the public throughout the process to ensure public concerns and aspirations are consistently understood and considered

Collaborate: To partner with the public in each aspect of the decision, including the development of alternatives and identification of the preferred solution

Empower: To place final decision-making in the hands of the public

Carnegie Memorial Pool Redevelopment

The detailed designs have been completed and a “fly through” tour can be found [here](#).

Heritage Victoria has completed the assessment, recommending that the pool is not added to the Victorian Heritage Register. The hearing has been scheduled for 17 May 2022. It would take up to 90 days from the hearing for the decision on the Heritage matter.

The additional time taken with the Heritage review means there is a further delay of 6 months on the initial start date for the project.

Artwork has been used on the fences to cover the site and to provide information to the community about the project. Federal funding has recently been pledged by all the major Parties ahead of the upcoming election.



Bentleigh Eat Street

Works are currently in progress at the ramp at the rear of Plaza and Daley Street car park. The first shelter has been installed and stage 1 works are almost complete



Lord Reserve Pavilion development

Work is progressing steadily with solar panels and window frames now installed.

Approximately 95 per cent of electrical, plumbing, mechanical and security works have been completed and brickwork will commence in April.

Glazing for windows which was due for installation has now been delayed until May.

The program is running slightly behind schedule due to resourcing challenges caused by the COVID-19 pandemic. Completion is expected in early July 2022.

New open space – Aileen Avenue

The park was officially opened by Hon. Lily D'Ambrosio MP and Glen Eira Mayor Cr Jim Magee, joined by Nina Taylor MP and Councillors.

The new open space features nature play, picnic tables and shelter, seating, open grassed areas, tree planting, garden beds and boardwalks.

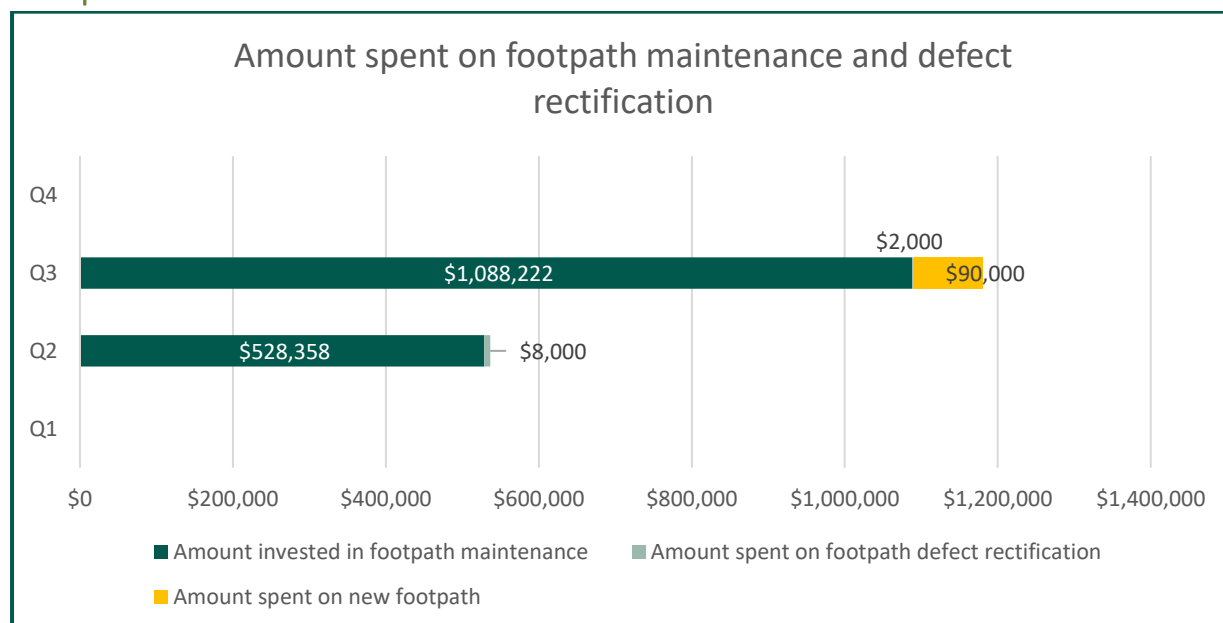
This project was made possible with the assistance of the Victorian Government through its Suburban Parks Program.



Pedestrian Safety Program

The tender has been awarded and construction is set to commence for traffic lights to be at Thomas Street, Bentleigh along the Elster Creek Trail and a zebra crossing to be implemented where the existing raised pavement exists to encourage more pedestrians to use the Elster Creek Trail and safely cross at Whitmuir Road, Bentleigh.

A total of \$1,090,222 was spent on maintaining and completing defect rectification works on our footpaths this quarter.

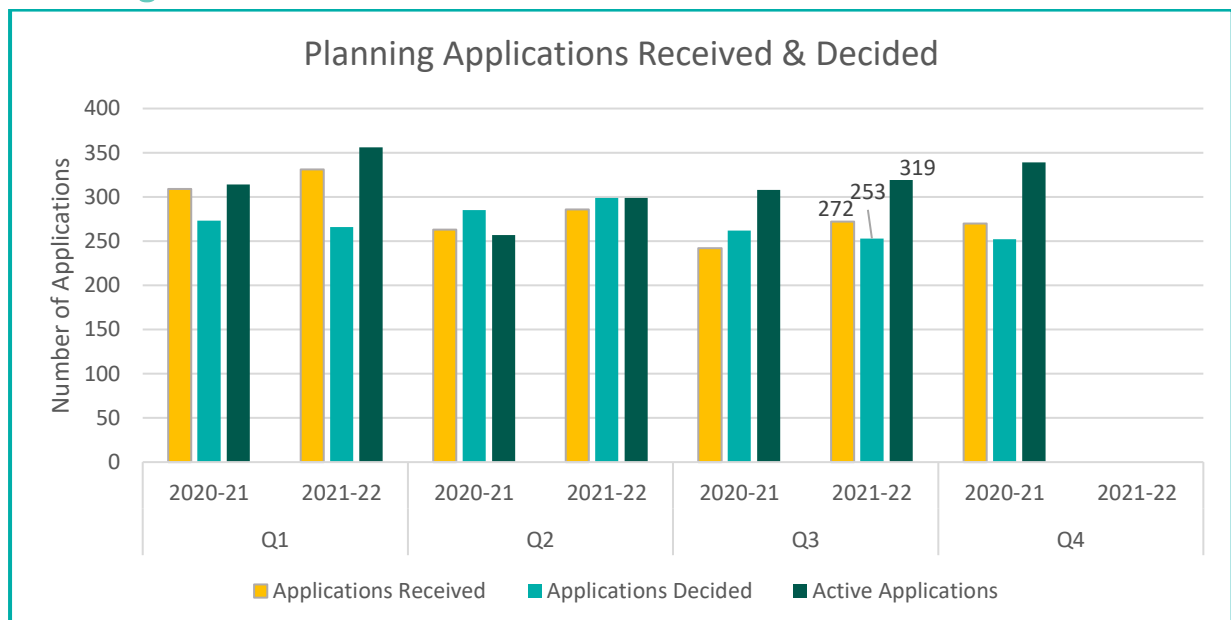

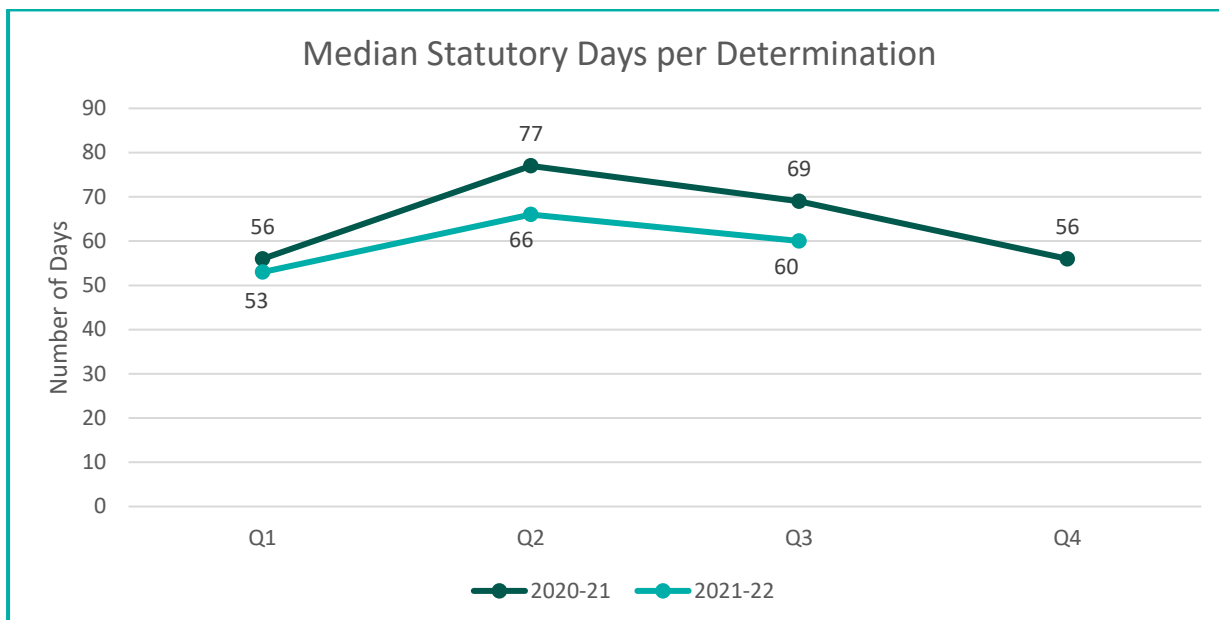

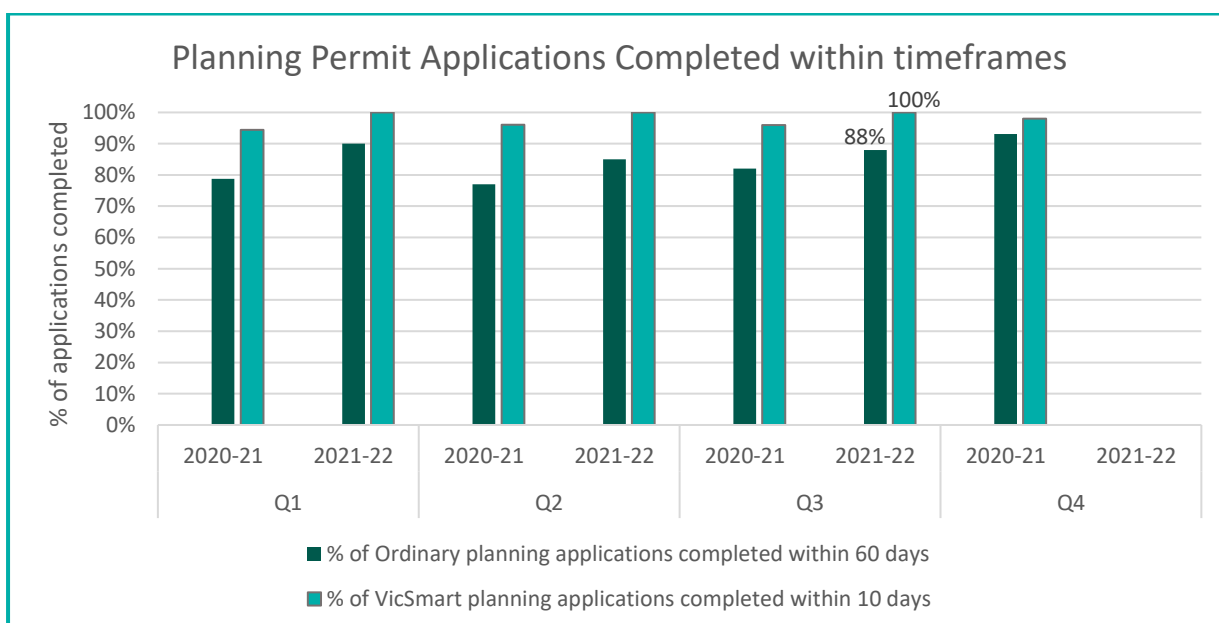

The trend in relation to the number of applications received and determined has not materially changed from previous quarters. The workload remains sustainable and Glen Eira continues to deliver one of the most efficient planning permit functions in the State.



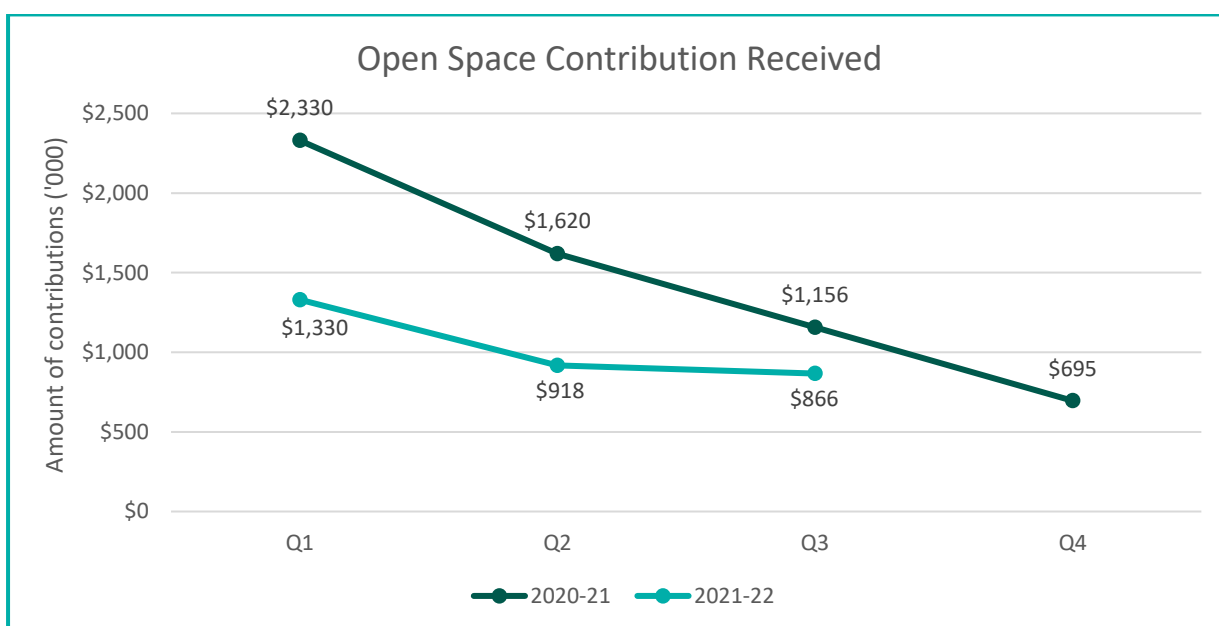
The median statutory days continues to be low. This is due to the efficient management of planning permit applications and a focus of staff to resolve matters quickly. When this is compared with the median days of other metropolitan Councils as part of the State Government reporting requirements, Glen Eira has a median that is 45 days lower than this average.



Glen Eira continues to deliver very high-quality service with one of the highest percentage of applications determined within timeframes within the State. When this is compared with the average for metropolitan Councils as part of the State Government reporting requirements, Glen Eira is approximately 35 per cent higher for regular planning permit applications and 29 per cent higher for VicSmart planning permit applications.

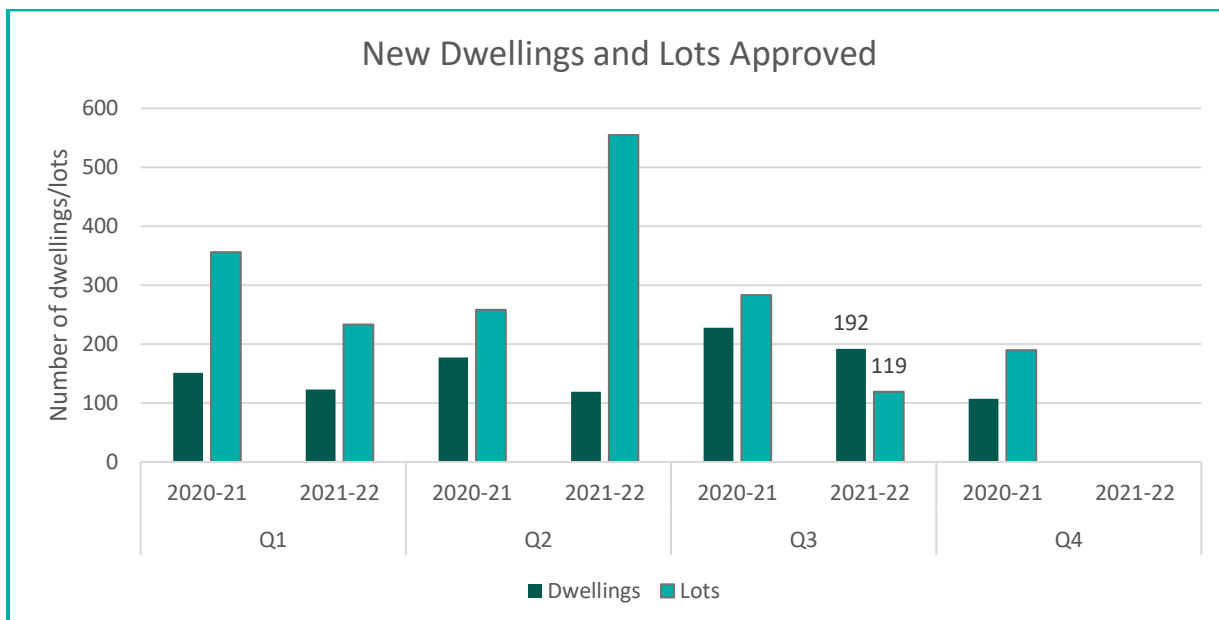


The number of reported planning breaches has reduced over the last quarter. All reported breaches are investigated and if substantiated, will be subject to enforcement action to resolve the breach.



The development sector has slowed due to the impacts of COVID-19. As a result, a lower open space contribution was collected.

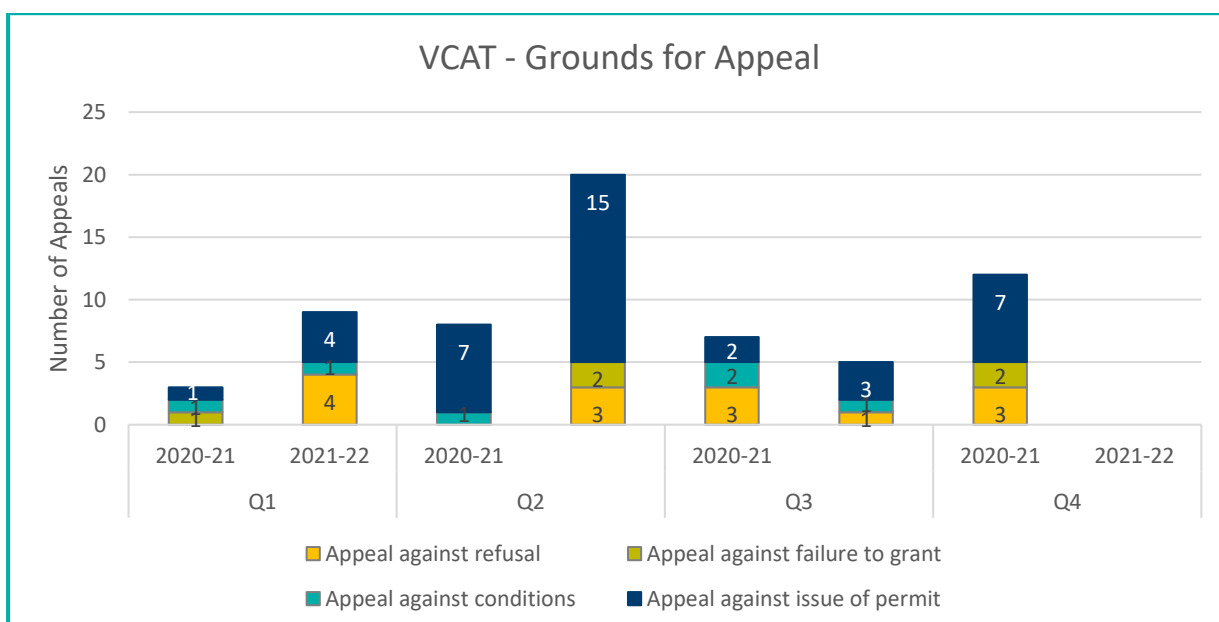
Council collects a public open space contribution when prescribed types of land is subdivided. This public open space contribution is held by Council in reserve and can only be spent to purchase new land to be used as open space (ie. a Council park) or to upgrade existing open space. This Quarterly Service Report measure details the value of public open space contributions collected for the quarter



Dwellings: The number of new dwellings approved shows that there is a sustainable pipeline of dwellings that could be built to accommodate future housing needs within the municipality. An approved permit that authorises a new dwelling does not imply that it will be constructed.

Lots: The number of new lots approved provides an understanding of future rateable properties. It includes lots for all types of uses including residential, commercial and other employment generating uses.

Lot: *A part (consisting of one or more pieces) of any land (except a road, a reserve, or common property) shown on a plan, which can be disposed of separately and includes a unit or accessory unit on a registered plan of strata subdivision and a lot or accessory lot on a registered cluster plan. 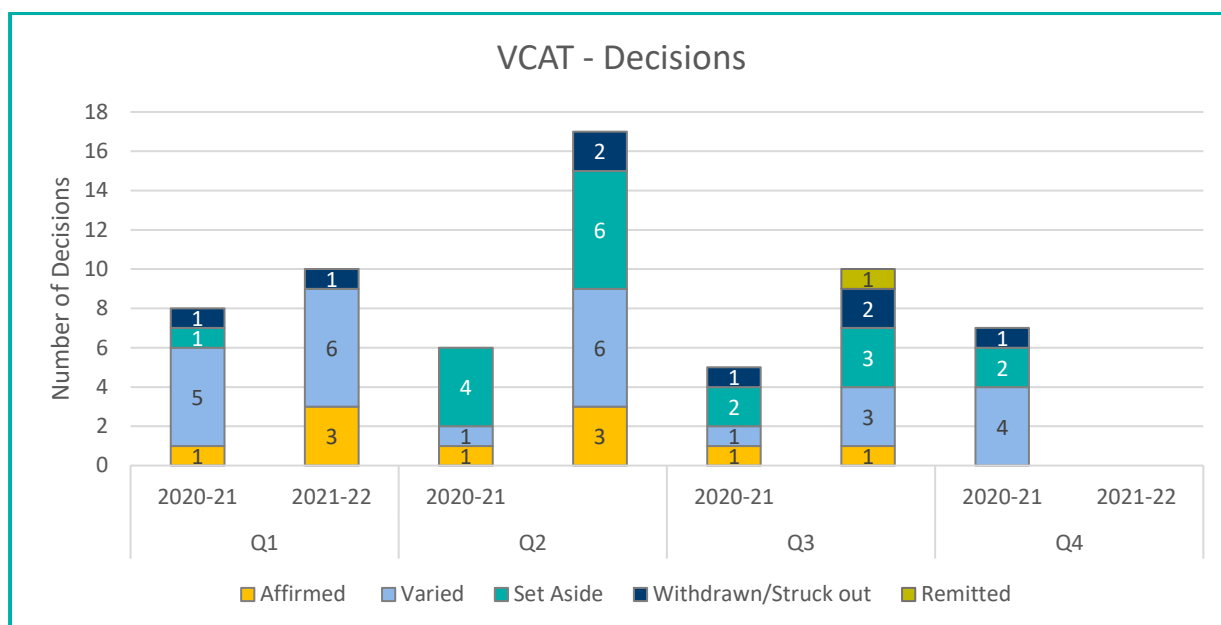
There has been a reduction in the number of appeals lodged this quarter. The data shows that there continues to be a higher proportion of appeals against the issue of a planning permit. This is a trend that we understand is common for many other municipalities. This will continue to be monitored to understand if this is a growing trend.

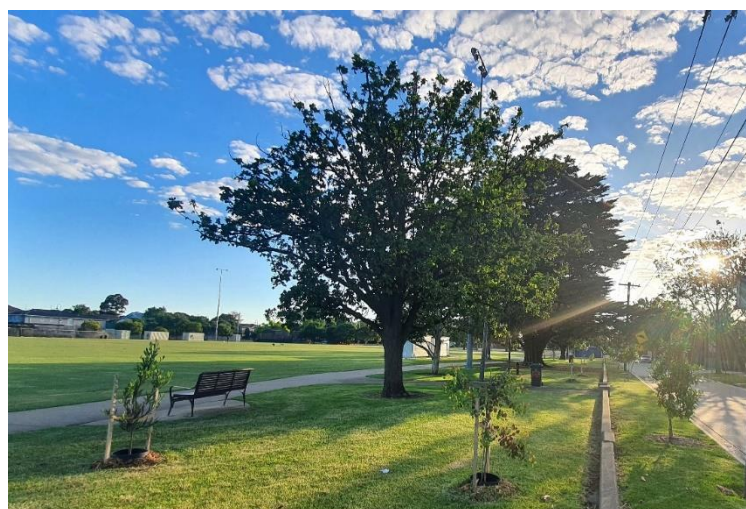
Project updates:

Urban Forest Strategy

Since the adoption of the *Urban Forest Strategy* on the 29 June 2021, Council has planted 160 trees across Lord Reserve and around the site of the Carnegie Swim Centre in Koornang Park. A mix of large, medium and small native trees were selected to provide the best outcome in terms of canopy, amenity and biodiversity.

Tree plantings for Moorleigh Community Village, Packer Park and Rosanna Reserve have been scoped and plans are currently being drafted to expand open space canopy cover across the municipality.

Council is also investigating innovative tree planting opportunities that will enable planting of trees in roadways and other areas that are currently devoid of tree canopy. Council will ensure that kerbside services and available on street parking will not be impacted significantly though the introduction of new street tree planting. One street that is currently being surveyed and designed is Parkside Street, Elsternwick. This program will then be expanded into other streets that will be identified as appropriate.



Classified Tree Register

To date, Council has received 400 nominations for individual trees and groups of trees to be included in the Register since opening the Register in September 2020. 83 trees have been endorsed by Council for inclusion in the Register, five nominations are undergoing a review at the request of a relevant landholder and two interim protection orders have been issued.

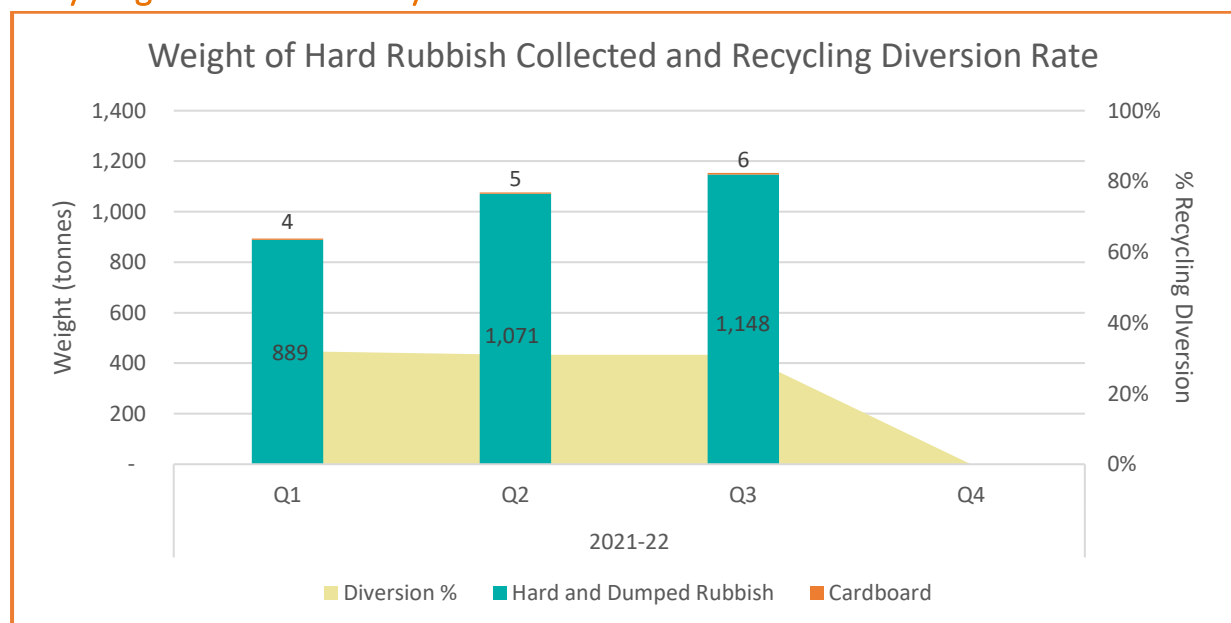

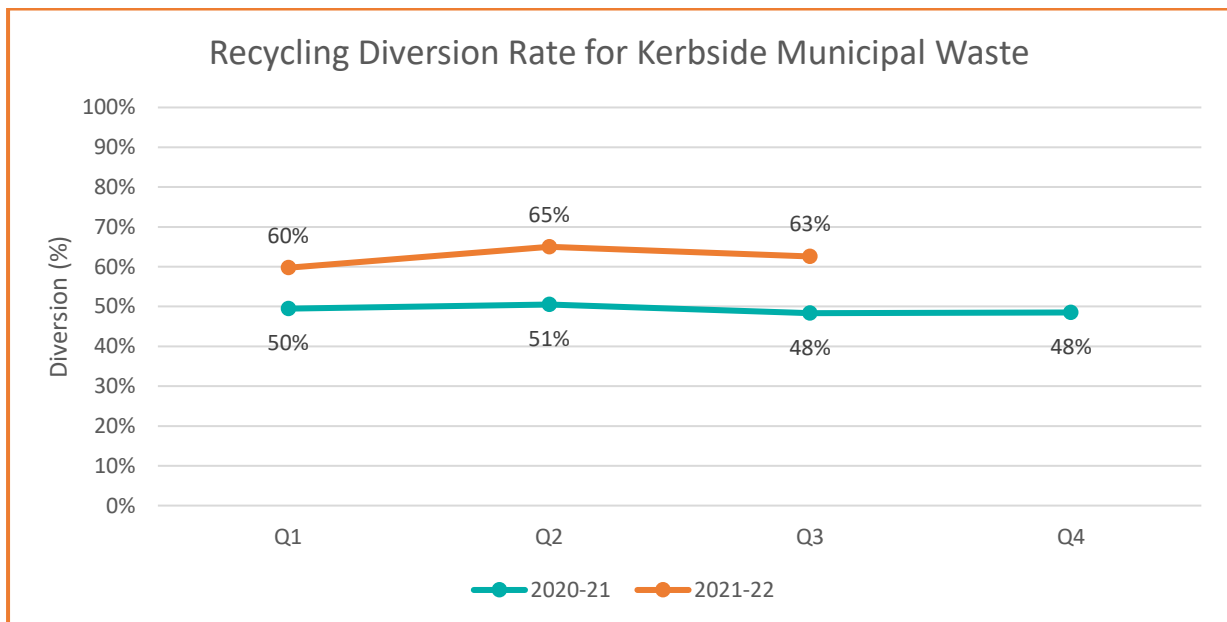

Recycling and Sustainability



The weight of hard rubbish collected, and number of hard rubbish collections has further increased from the last quarter as expected around the beginning of the year. This trend is consistent with last year.

The number of hard rubbish collections remains high as well as the overall weight of waste to landfill. The hard rubbish recycling rate is therefore consistently hovering around 30 per cent.











The kerbside recycling rate remains consistently higher compared with the same time in previous years. This is due to more food and garden organics being recycled and less waste sent to landfill.

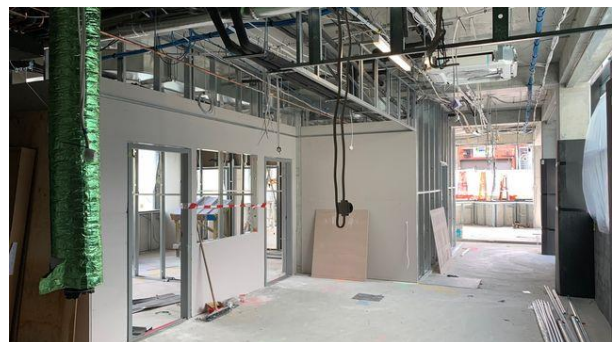

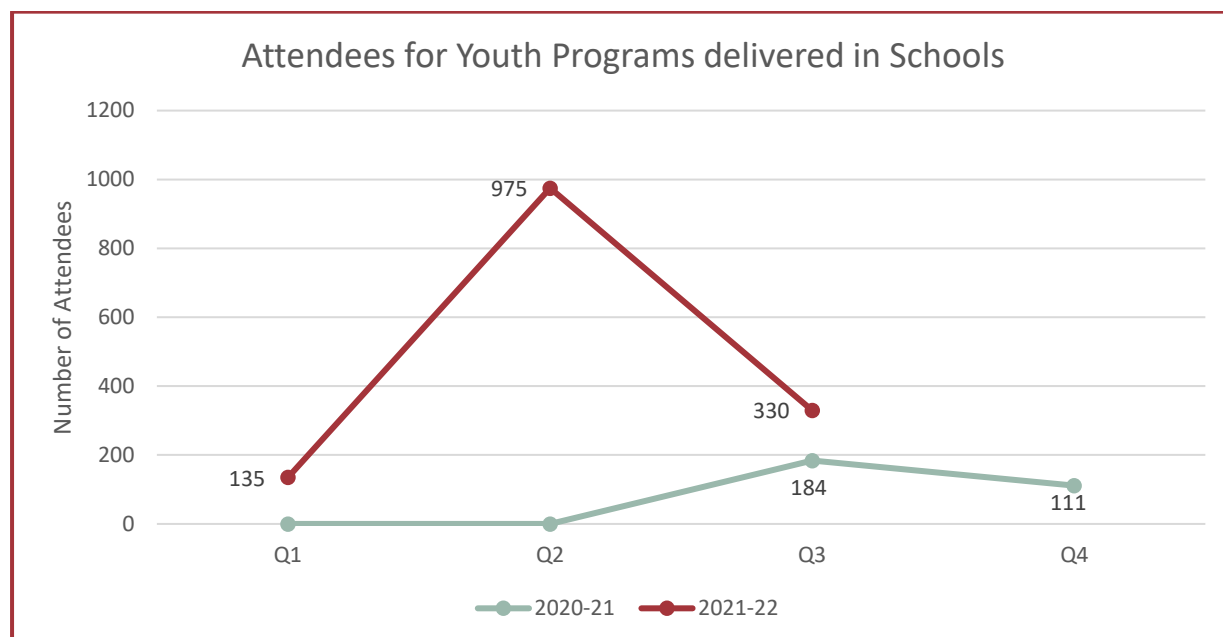
Bentleigh Library and Youth Hub

Construction of the Bentleigh Library and Youth Hub is scheduled to be completed in August 2022. This project has been delayed due to the restrictions implemented by the Government (25% capacity limit) and the two-week shutdown.

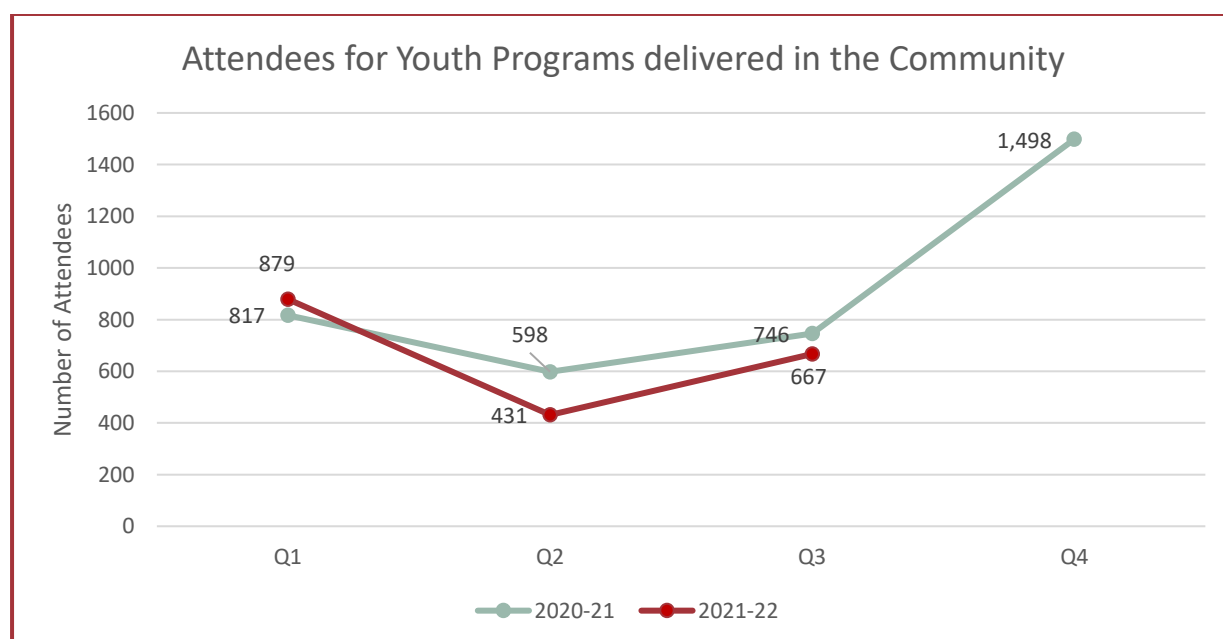


Youth Services

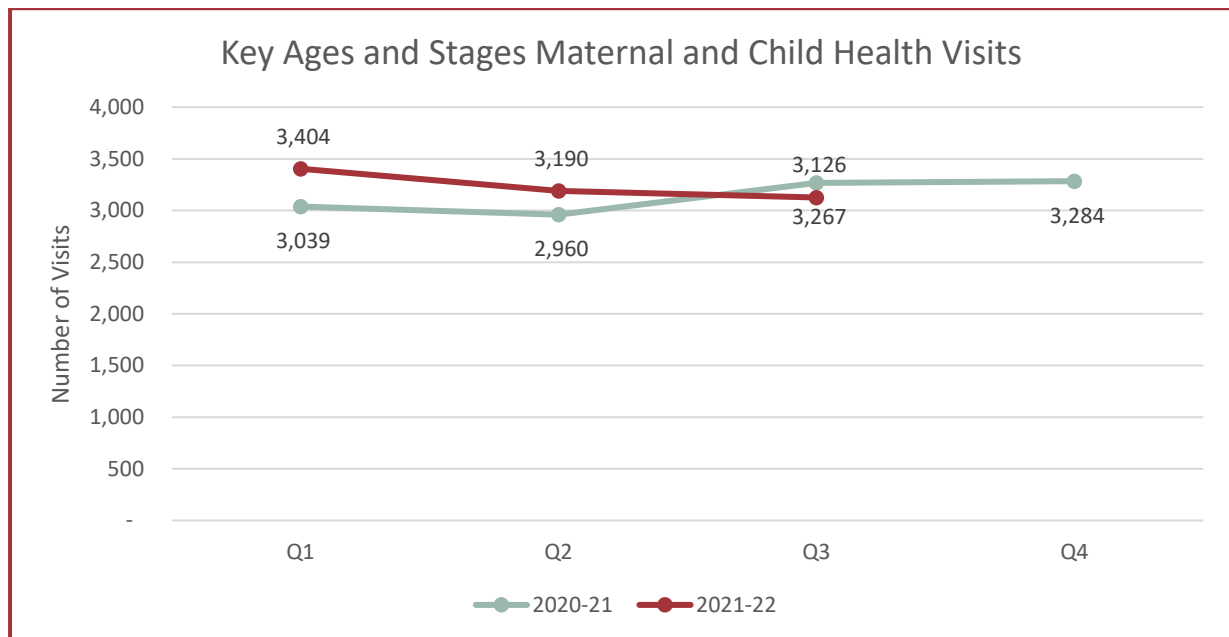


Community based programs delivered during this quarter included:

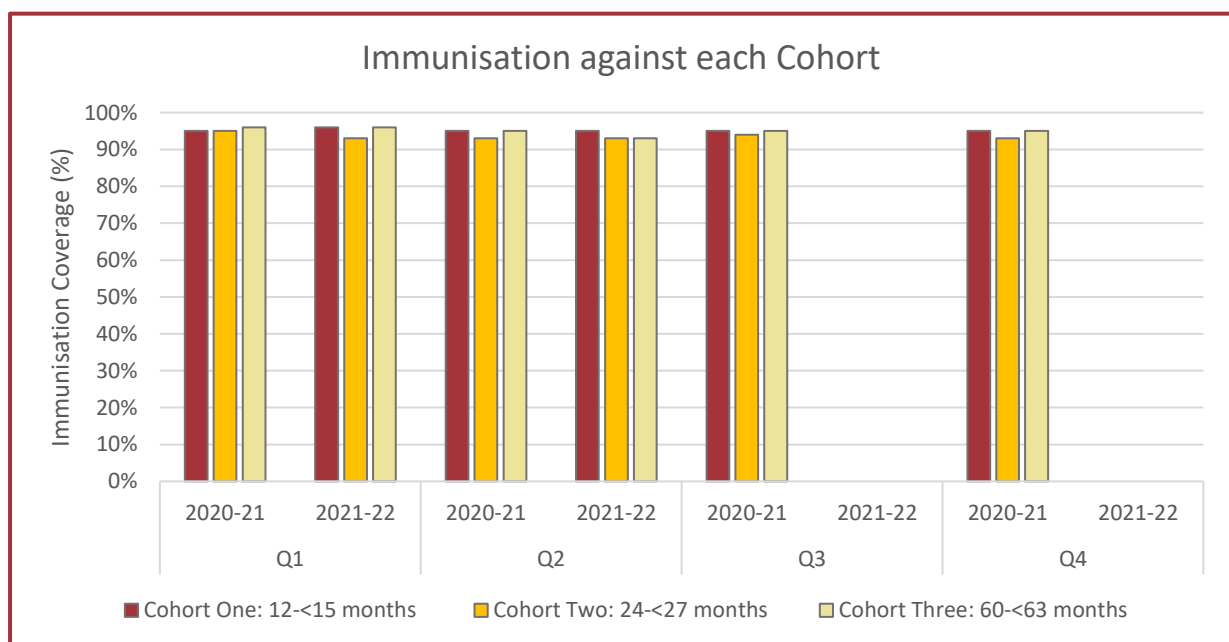
- *Press Start*, a program to support positive social gaming and promote healthy habits.

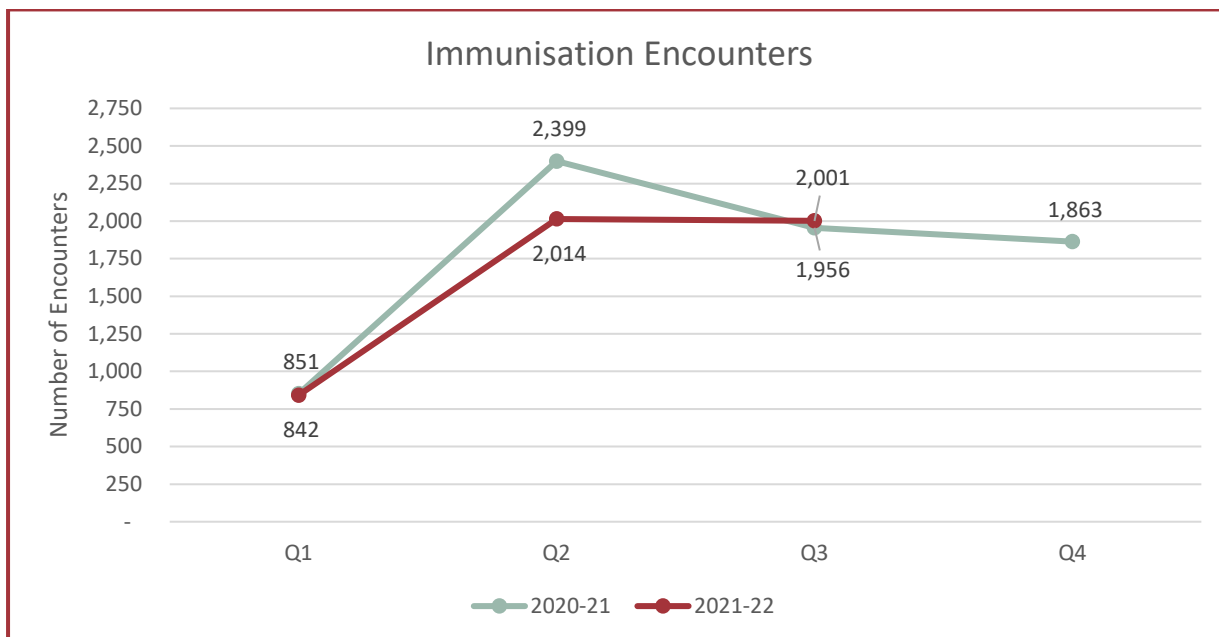
Children's Services



During this quarter, the Municipal Association of Victoria and the Department of Health and Human Services required us to prioritise our Maternal and Child Health service to infants aged 0-8 weeks and families needing additional support. This allowed us to assist other Councils that were unable to deliver service to prioritised families with infants aged 0-8 weeks and those needing additional support due to the impacts of COVID-19 on their Maternal and Child Health workforce. Glen Eira's Maternal and Child Health Service resumed normal operations from early March 2022.

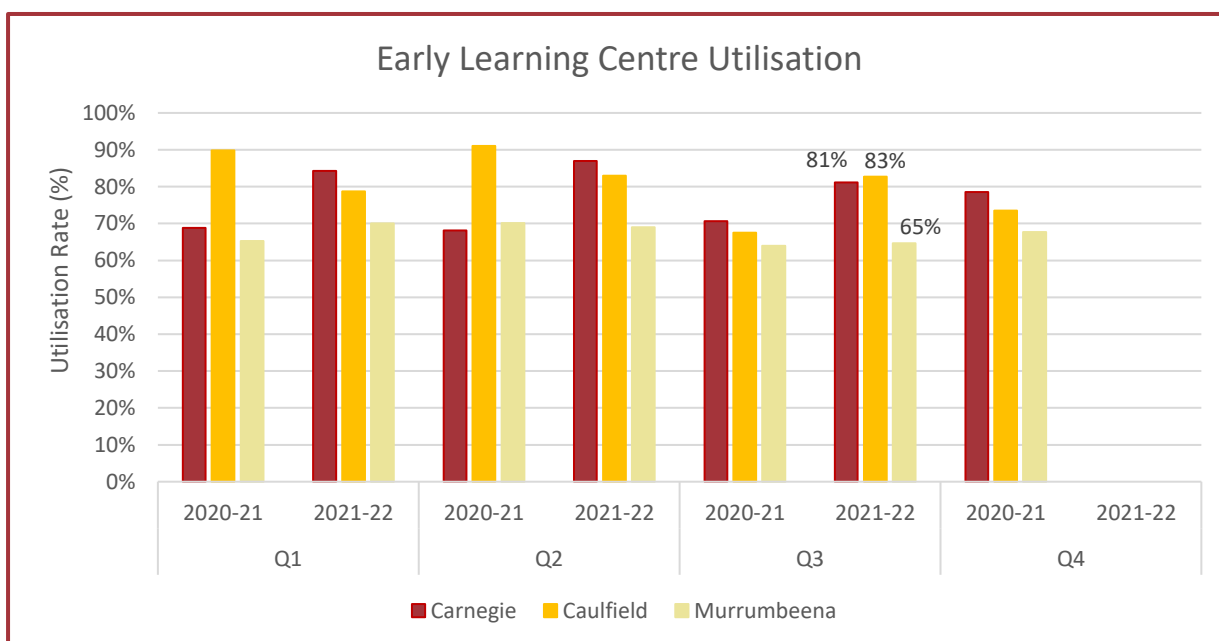

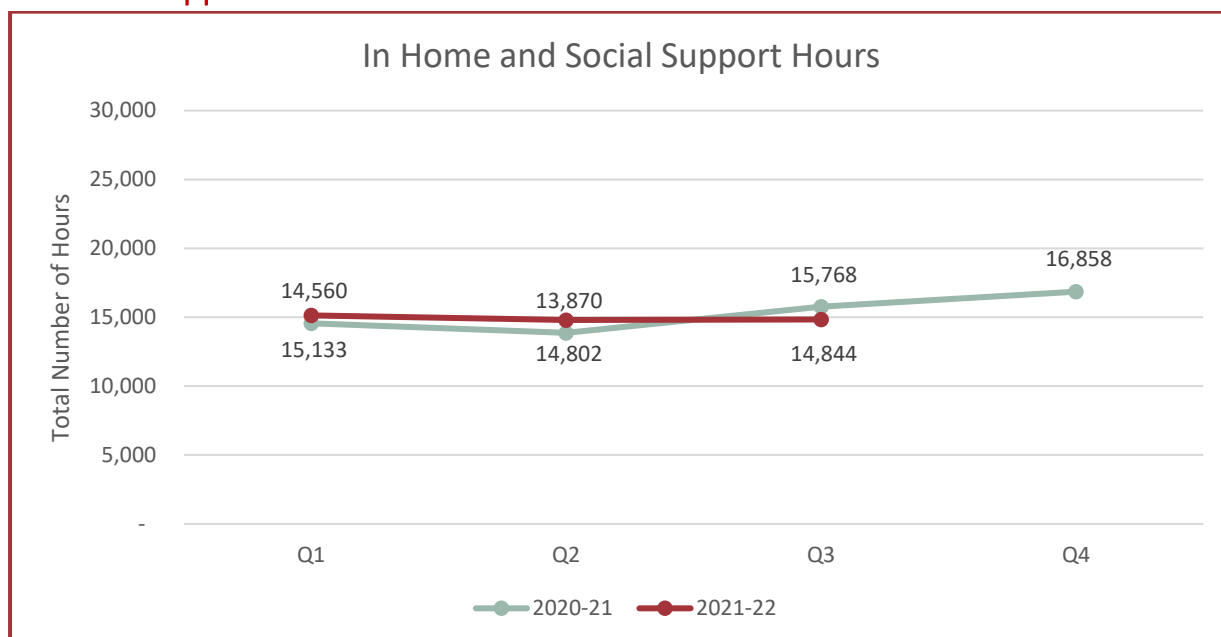
This quarter included 789 clients immunised as part of the community immunisation sessions and 1,212 students immunised as part of the *School Immunisation Program*.

Increased utilisation during this quarter is due to the easing of COVID-19 restrictions impacting attendance and enrolments, and increased family confidence in returning to early learning services.

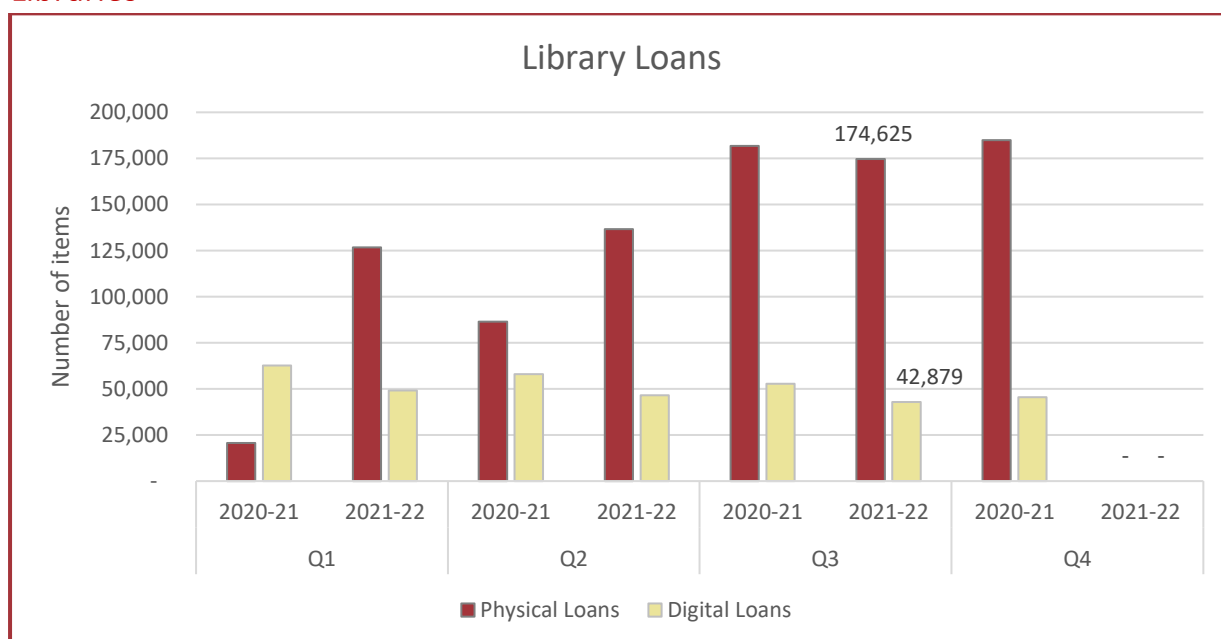
In Home Support



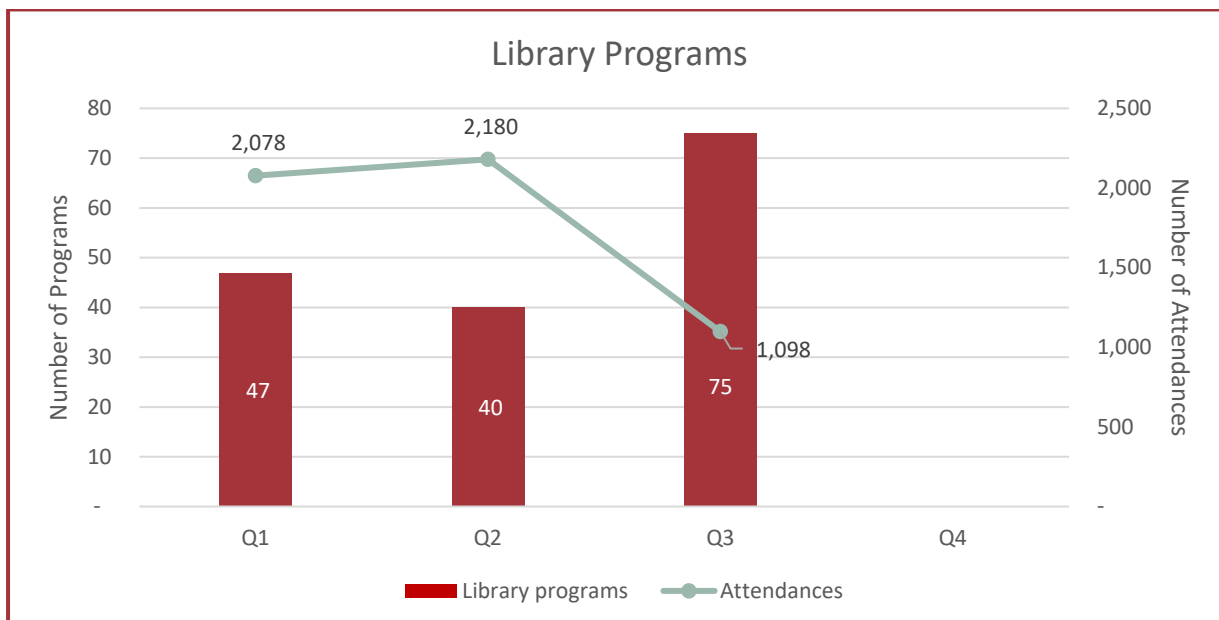

COVID-19 continues to impact with services being cancelled due to fear, exposure sites, isolation and illness.

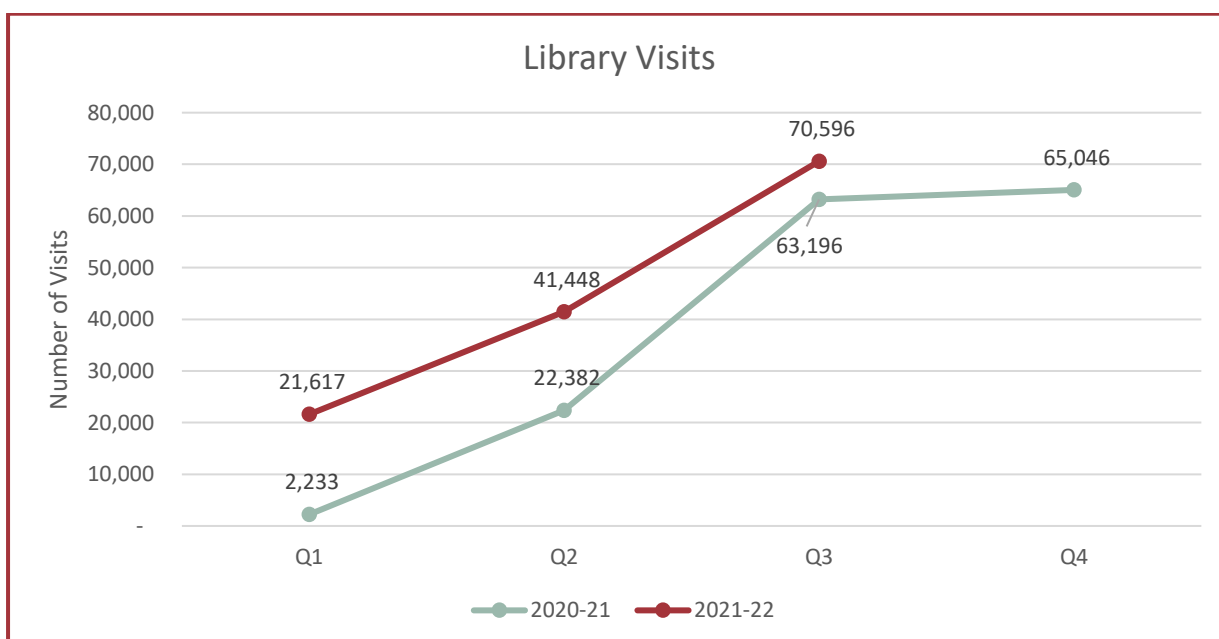
Libraries

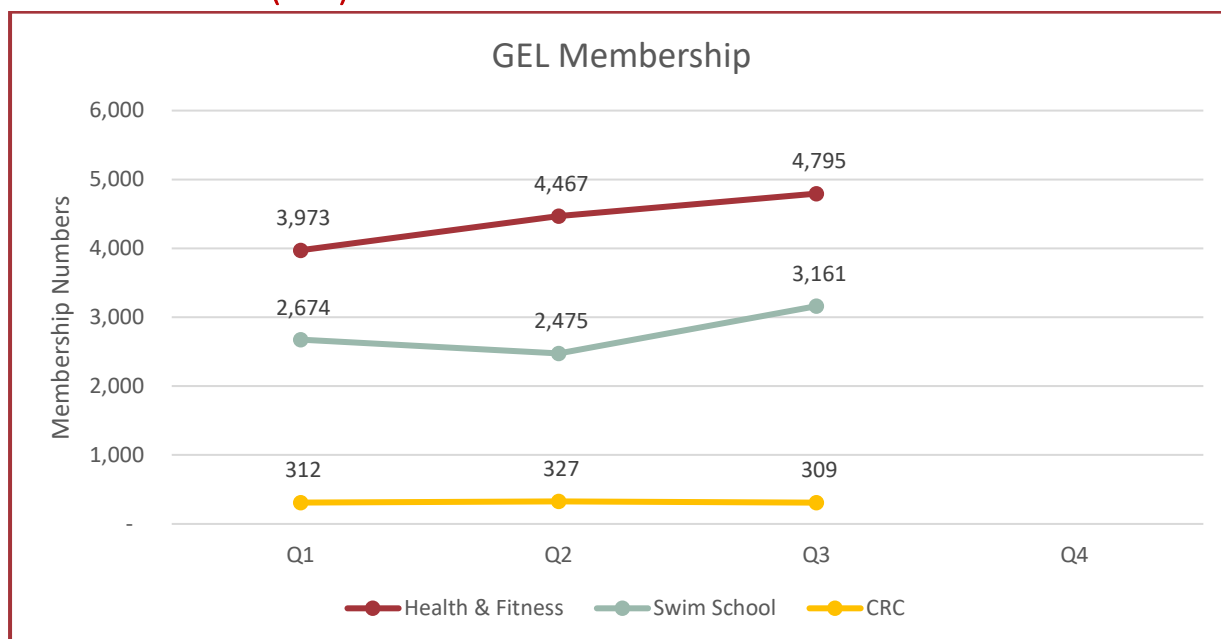


Although the number of programs increased, there has been a dip in attendance numbers this quarter. This is likely due to warmer weather, the easing of restrictions, and the slow but steady uptake of a hybrid online/face-to-face program. There has also been a focus this quarter on more targeted events. *Babytime* and *Storytime* returned to the branches in March with a likely return to pre-COVID capacity soon. It is anticipated that programming numbers should stabilise next quarter.

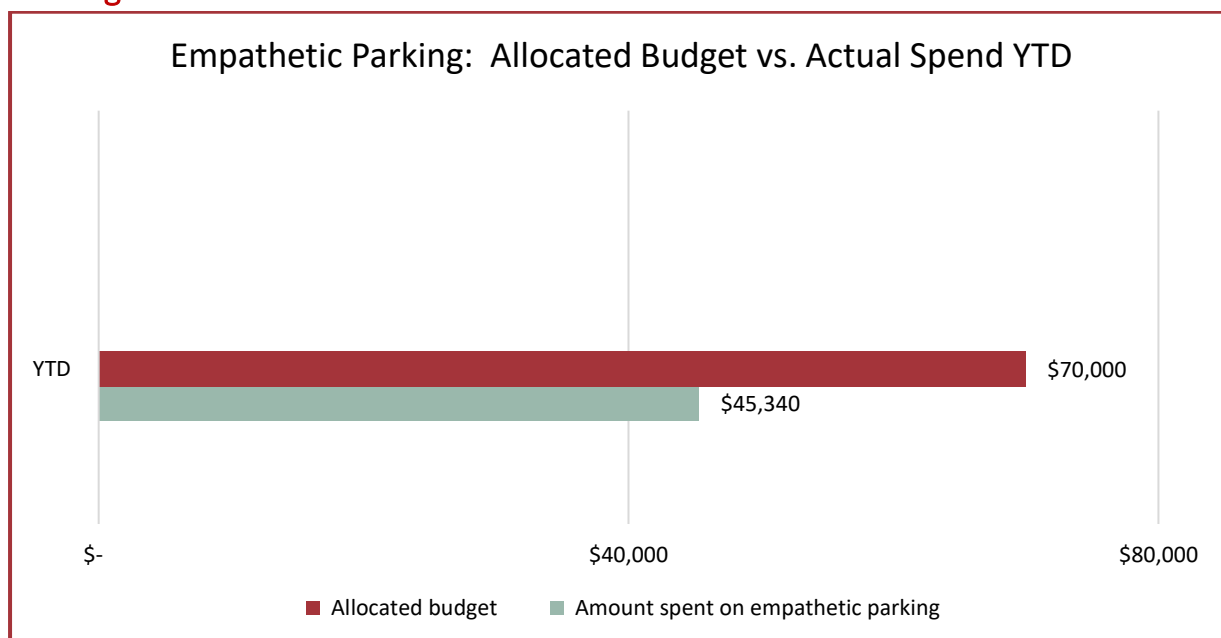


Health and Fitness: The number of Health and Fitness memberships continues to steadily increase post COVID-19 restrictions.

Food Safety



Council's Environmental Health Officers are focusing on allergens and labelling requirements during Food Safety Assessments, in line with the Department of Health training and attention for Victorian Food Businesses. This focus has resulted in an increase in failed inspections which require a follow up inspection. Additionally, COVID-19 impacts on food business operations are a common theme for those businesses failing an inspection.

A failed inspection is when a deficiency is found by a Council officer that poses a risk to public health and must be followed up by the Council. This includes situations where there is a serious risk of food being sold that is unsafe to eat.

Engagement Overview January to March 2022



Feedback on the draft Smart Cities Roadmap closed on 21 February and was endorsed by Council on 15 March 2022. The Roadmap provides direction for the ways in which we can use data, enhance connectivity, and improve digital technology to deliver improved services with greater efficiency to the Glen Eira community.



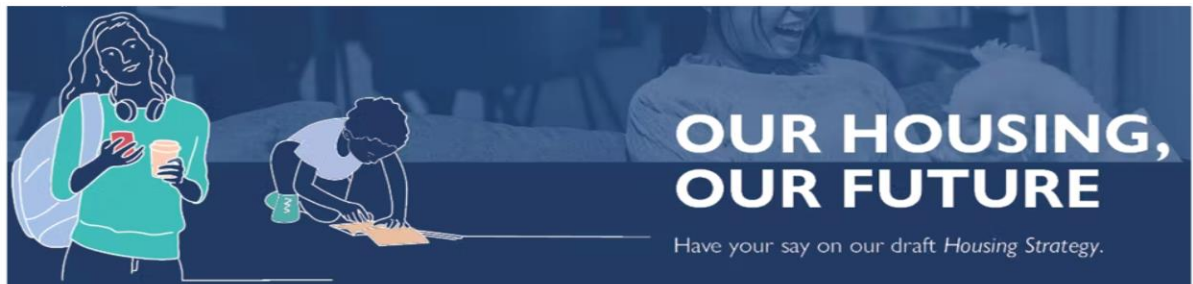
We are developing a Placemaking Framework which will provide guidance to stakeholders on Council and community placemaking projects, assist in the activation and revitalisation of public spaces, encourage community interaction and guide the delivery of projects and events by both Council and the community.

Phase one of community engagement is open from 20 February to 3 April 2022. Feedback from the engagement will help influence preparation of the draft Placemaking Framework, which will be presented to the community for further consultation in July 2022.

PACKER PARK PLAYGROUND UPGRADE SURVEY



Phase two of community engagement on the Packer Park Playground upgrade closed on 7 March 2022. We are currently reviewing all 370 survey responses and will prepare a report for Council on the feedback received.

Draft Caulfield Structure Plan



We have developed the draft Caulfield Structure Plan, which outlines a vision for the area's future and illustrates how a more accessible and integrated network of places could be created.

With support from the Victorian Planning Authority (VPA) we have carried out long-term planning to help shape the opportunities that come with the anticipated government and private-sector investment in the area.

Phase three community engagement will close on 10 April and online surveys and submissions will close on 24 April 2022.



Between September and November 2021, we engaged with community members, local traders, Victoria Police, community service organisations, government agencies and internal staff to better understand public perceptions of safety.

The feedback received from this first period of engagement helped to inform the development of the draft Community Safety Plan 2022-2025, which includes three key themes which the Plan will address over the next three years.

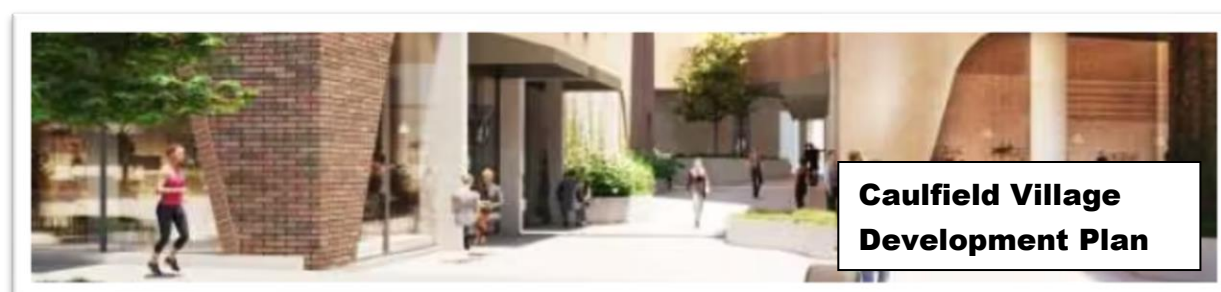
The final community engagement will close on 20 April 2022.



The Asset Plan is a 10-year document that guides the way Council prioritises and manages its assets to increase their lifespan whilst ensuring that their replacement, disposal, upgrade or renewal occurs at the right time and in the most cost-effective manner.

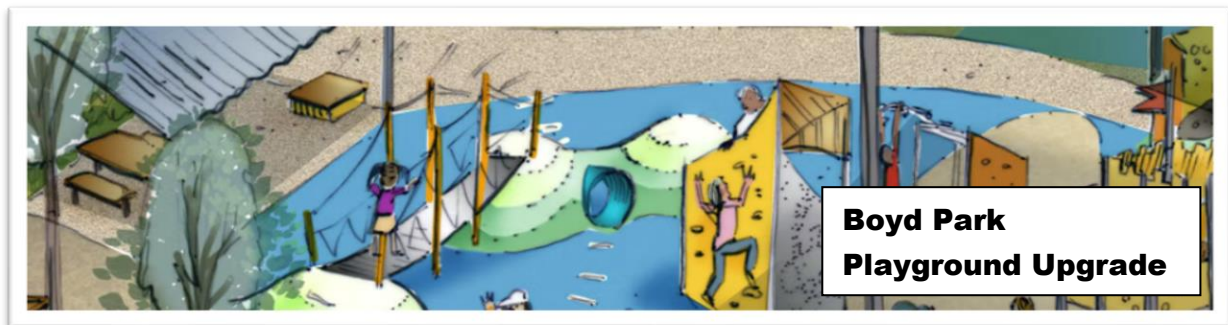
Phase one of community engagement is open from 7 March – 4 April 2022. The community will be able to provide feedback online by completing the Asset Plan survey and in writing.

Phase two of engagement will commence from 30 April – 7 May 2022. This engagement will be in-person, where a deliberative panel will be informed through a random selection process and participants will participate over two sessions to provide detailed feedback.



The community have until 1 April 2022 to provide feedback on the Development Plan application for mixed-use development of 14 storeys at 31 Station Street, Caulfield East. The site is the next stage of the 'Caulfield Village' development and is located to the east of the recently constructed Caulfield Boulevard.

The next stage of engagement involves inviting any parties who have made a submission to attend a planning conference, where they will be able to elaborate on their submissions to a member of the Councillor group. The Conference will also include the assessing Urban Planner, and the Permit Applicant.

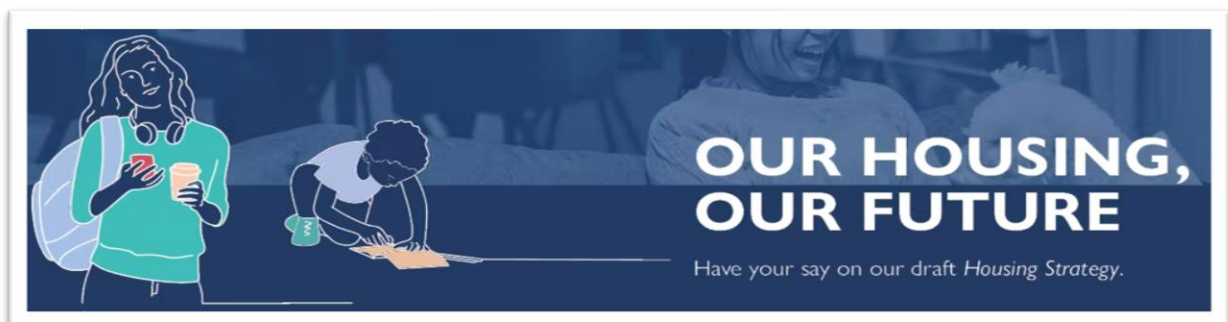


A concept design was developed for the Boyd Park Playground. The design incorporates an expansion on the existing play equipment, the inclusion of all abilities access elements, nature play and intergenerational play equipment. Additional social facilities have also been introduced and as the community requested, a public toilet will be constructed in the park to the north of the playground.

Community feedback on the concept design will close on 24 April 2022.

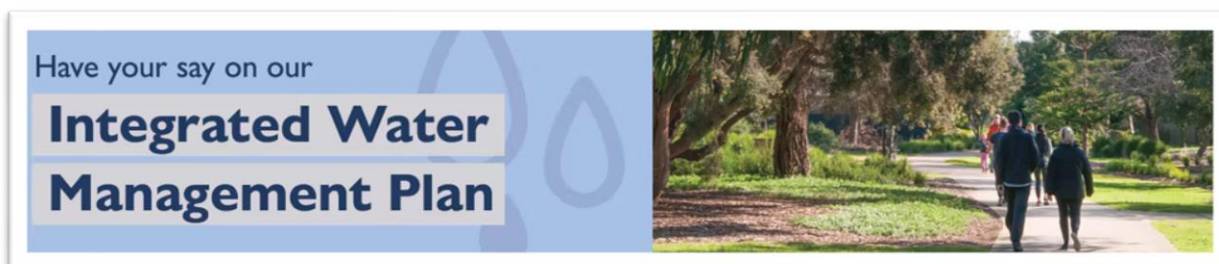


We are seeking your feedback on the draft Mackie Road Reserve Master Plan which will guide future development and investment.

- Creation of an off-lead dog park for our furry friends in Orange Reserve.

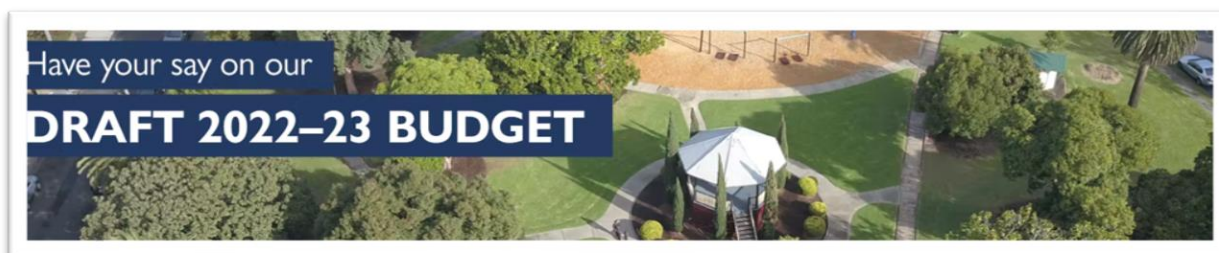

In the draft 2022–23 Budget, we have allocated \$35.69 million for asset renewals, upgrades and expansions including Open Space Strategy implementation; sustainability initiatives; building improvements; community safety projects; and the renewal and upgrade of Council's major infrastructure assets such as footpaths, drains and roads. The draft Budget also includes information regarding your rates and residential garbage charges.

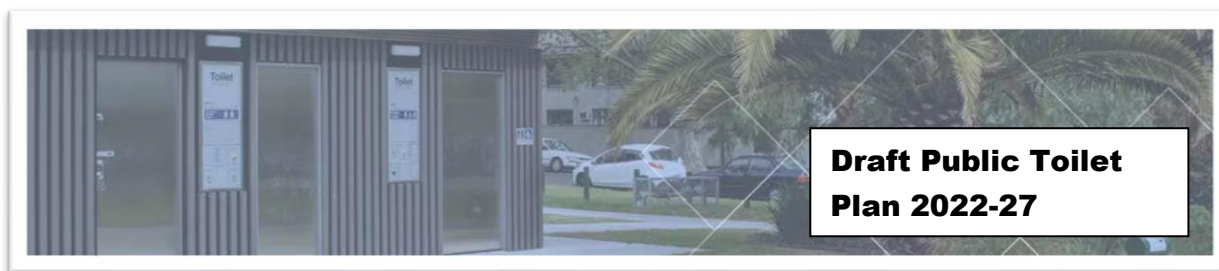

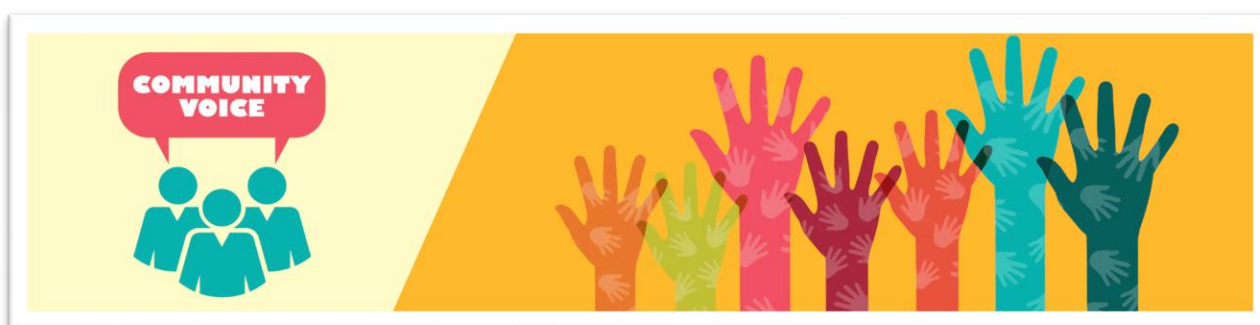
