# 4.1 ROAD DISCONTINUANCE PROPOSAL - MERRIWOOLA STREET, ST KILDA EAST

That Council:

- considers the written submissions received and hears any verbal submissions with respect to the proposal to discontinue a part of Merriwoola Street, St Kilda East as shown hatched in Attachment 1 (the Road) and to sell the land from the road, if discontinued, to the Caulfield Grammar School (the School) pursuant to sections 206, schedule 10, clause 3 and 207A(a) and 223 of the Local Government Act 1989 and section 114 of the Local Government Act 2020.
- notes that a further report, including a summary of the submissions received at this meeting, will be presented to a future meeting of Council for a decision by Council whether or not to discontinue the Road and sell the land in the discontinued road to the School or to discontinue only a part of the Road, or not to discontinue the Road and sell the land.
