TERMS AND CONDITIONS OF PARTICIPATION IN SOUNDS OF GLEN EIRA 2019

It is acknowledged and agreed that:

- I Swearing and the use of otherwise offensive language of any description, at any time during a performance, either in song lyrics or on stage, is not permitted and, if used, will result in the immediate termination of a performance.
- 2 Unruly behaviour, or encouraging unruly behaviour eg. crowd surfing, is not permitted and persons engaging in, or encouraging, unruly behaviour will be required to leave the event.

- 3 The event is alcohol, drug and smoke free and the use of alcohol, drugs or cigarettes on the premises is not permitted. Persons using, or under the influence of, alcohol, drugs or cigarettes will be required to leave the premises.
- 4 Musicians must arrive at least 30 minutes prior to their allocated performance time, which cannot be changed.
- 5 If selected vocalist performers require a backing track to be played during their performance, they will need to submit the track in DC. in .wav format by Friday 31 May 2019.
- 6 The time limit for each set is 20 minutes maximum. This does not include the five minutes allowed to set up prior to each set. The back stage crew will indicate when it is the end of the set.
- 7 Musicians must provide Council (with this registration form) a stage plan of the band line up, including where each performer will be placed and their instrument requirements (such as amplifiers etc.).(A template is enclosed to use as a guide).
- 8 Council is not responsible for any loss or damage caused to any property owned, leased or hired by bands or any band members or their representatives or anyone accompanying the band members. Bands are advised to make their own insurance arrangements.
- 9 Council will arrange public liability insurance for performers participating in the event but performers retain the responsibility of ensuring that all reasonable safety precautions are undertaken during performances and participation in the event generally.
- 10 Performers will not receive payment for their performances but will be considered for one of the following prizes:

First place: two days professional recording at Glen Eira Youth Service *Plugged In* recording studio (at a time to be mutually agreed).

Second place: \$200 gift voucher.

Third place People's Choice Award: \$200 gift voucher.

Prizes cannot be exchanged for money and are not transferable. One of the finalists may be chosen to perform at the 2020 Party in the Park — Under the Stars event.

- 11 The winning bands will be announced by the judges at the end of the event. The judges' decisions will be final and no correspondence will be entered into in relation to their decisions. The names of the winning bands and individual performers will be posted on Council's website and featured in *Glen Eira News*.
- 12 At least one of the performer/s from each band must attend a pre-event meeting to be held on Friday 14 June from 4pm to 4.30pm at Glen Eira Youth Information Centre, 86 Robert Street, Bentleigh.
- 13 Non-compliance with these terms and conditions of participation may result in either termination of the bands performance or a request that the band member/s leave the event.
- I4 For a band to be eligible to compete in *Sounds of Glen Eira 2019*, at least one of the performers must live, work, socialise or study in the City of Glen Eira.
- 15 For your chance to play at *Sounds of Glen Eira 2019*, please provide Glen Eira City Council Youth Services with a copy of your demo CD, short band biography and contact details for each band member. Entries close 4pm, Friday 31 May 2019.
- 16 All performers at Sounds of Glen Eira 2019 must adhere to strict noise restrictions. Sound produced by any means must not exceed 95-100db in volume. Failure to abide by this restriction will result in an initial warning. If the failure persists, the performance will be stopped and the performers will be requested to leave the stage.
