1. Simone Zmood – Caulfield North

Given the State Government has publicly acknowledged that there will be no state government funding, it seems that a better use of ratepayer funds would be to improve the cycling infrastructure in the centre of the municipality – rather than at one edge – so that the cycling facilities can be used by a wider range of Glen Eira residents and ratepayers. Has the Council considered running the safe cycling corridor Pilot in another area of the City of Glen Eira entirely – preferably one where the residents and traders actually want the infrastructure – rather than persisting with connecting Monash University/Caulfield Station to St Kilda Road at this stage? If not, why not?

Response:

The pilot project through North Caulfield does not sit in isolation and is part of the broader network of Safe Cycling Streets that aim to provide efficient and safe transport options for the whole municipality. The Safe Cycling Streets will work with the other identified premium transport corridors from the Integrated Transport Strategy to create a strategic and integrated transport vision for Glen Eira that allows all residents the options of efficient active travel, vehicle travel or public transport travel.

At the 26 September 2018 Council Meeting, the North Caulfield corridor was chosen out of three possible options as the pilot Safe Cycling Street. You can read the full assessment behind this decision in the meeting agenda available through Council's website. The decision was based on the:

- Significant East-West cycling potential;
- Connection of Caulfield (and Djerring Trail) to St Kilda Road Corridor; and
- The closer proximity to Melbourne CBD (largest workplace location in Glen Eira).
