10. OFFICER REPORTS (AS LISTED)

10.1 99 BREWER ROAD BENTLEIGH - AMENDED APPLICATION

Moved: Cr Daniel Seconded: Cr Esakoff

That Council issues a Notice of Refusal to Grant an amendment to a Planning permit for Application No. GE/DP-33820/2020/B at 99 Brewer Road, Bentleigh on the following grounds:

- The proposed operating hours for the food and drink premises are inappropriate and fail to address the acoustic and overall amenity impacts towards the prevailing residential context. The application therefore does not meet the following decision guidelines of the Industrial Zone 3:
 - a. The Municipal Planning Strategy and the Planning Policy Framework.
 - b. Interface with non-industrial areas.
- The proposed onsite car parking allocated to the food and drink premises is insufficient. The proposed car parking demand, when factoring in the existing parking reductions approved under the permit, will have an unreasonable impact on the existing parking availability within the surrounding residential streets, failing to satisfy the provisions of Clause 52.06 (Car Parking).
- 3. The proposed operating hours for the food and drink premises and medical centre are unsatisfactory due to the compounding vehicle movements and parking overflow when factoring in the existing parking reductions approved under the permit and the current site context.
- 4. The proposed changes to condition 9 to increase the number of children that may be present on the land at any one time are unsatisfactory due to the compounding increase of vehicle movements and parking overflow when factoring in the existing parking reductions approved under the permit and the current site context.

10.4 MUNICIPAL ASSOCIATION OF VICTORIA OCTOBER 2025 STATE COUNCIL MOTIONS

That Council endorses the following two motions for submission to the 10 October 2025 Municipal Association of Victoria (MAV) State Council meeting:

Motion 1 – Support for local initiatives to accelerate climate action

That the State Council of the Municipal Association of Victoria (MAV) calls on the Victorian Government to partner with local government in responding to the climate emergency through:

- 1. Fast-tracking electrification and emissions reduction initiatives for essential community infrastructure, such as neighbourhood centres, aged care facilities, public housing, and community centres.
- 2. Expanding opportunities for councils to upgrade local infrastructure and improve resilience to extreme weather events, with attention to the differing needs of urban, regional and rural municipalities.
- 3. Improving household and business access to:
 - Electric retrofitting alternatives
 - Renewable energy (including off-grid systems)
 - Insulation and energy efficiency upgrades
 - Conversion from gas and woodfire heating to electric systems
 - Solar PV panels and batteries tailored to local conditions.
- 4. Ensuring these programs are equitable and accessible, particularly for low-income earners, renters, First Nations communities, and other vulnerable groups across metropolitan, regional, and rural area.

Motion 2 – Protecting and expanding urban tree canopy through planning and vegetation management reform

That the Municipal Association of Victoria (MAV) advocate to the Victorian Government for urgent reforms to better protect and grow urban tree canopy, including:

- Recognising the role of tree canopy in climate resilience, public health, biodiversity, and urban amenity in planning decisions
- Moving away from broad vegetation clearance practices around powerlines in low bushfire-risk areas, where safety risk is low
- Endorsing evidence-based minimum vegetation clearance (e.g. 30cm) where appropriate—such as in inner metropolitan Councils that are classed as Low Bushfire Risk Areas (LBRA)
- Establishing statewide standards and targeted investment to support councils in retaining and expanding canopy cover through planning controls, infrastructure coordination, and local greening initiatives.
