Guidelines for the issue of multiple pet permit

- 1. Applications must be on the correct form.
- 2. All sections of the application form must be completed.
- 3. The application form must contain the original signature of the applicant.
- 4. The application form must be emailed to mail@gleneira.vic.gov.au
- 5. Granting of the Permit is subject to inspection by an authorised Council officer
- 6. Fee for Permit: \$72.40 See below for payment details.
- 7. Permit duration: three (3) years
- 8. Council will consider the following when assessing applications:
 - Condition of the premises clean, inoffensive and sanitary condition, level of maintenance to minimise any nuisance.
 - State of the ground where the animal is kept free of weeds, refuse, rubbish and other material harbouring or which may harbour rats and vermin.
 - Method and frequency of disposing of animal excrement.
 - Current registration of animals.

- Whether the presence of the animals that are the subject of the Permit application causes or may cause a detriment to the area's amenity.
- Whether the welfare of the animals may be compromised.
- Requirements of the Domestic Animals Act 1994, its Regulations and Part 11 of the Glen Eira City Council Community Local Law have been adhered to.

Conditions that will be imposed if a multiple pet permit is issued

- 1. The premises must be kept in a clean, inoffensive and sanitary condition and must be maintained so as not to cause any nuisance.
- 2. The ground where the animals are kept must be free of weeds, refuse, rubbish and other material harbouring or which may harbour rats and vermin.
- 3. Animal excrement must be removed regularly and disposed of in a clean and thorough manner.
- 4. Each animal must be registered with Council every year.
- 5. A new permit must be applied for if new or additional animals are to be kept on the premises.
- 6. Noise emissions must be kept to a minimum and not cause detriment to the amenity of the area.
- 7. The welfare of the animals must not be compromised.
- 8. The Domestic Animals Act 1994, its regulations and Part 11 of the Glen Eira City Council Community Local Law must be adhered to.
