1. Elissa Blackman - Murrumbeena

What will happen if a council position is not formed for an amended plan especially during the period of the election when the VCAT hearing is due? We are aware that the result of the election may take longer than normal and the hearing date for the 430-434 Neerim Rd, Murrumbeena application commencing 23rd November 2020 may occur before a position of the newly elected council is sought.

Response:

All parties to the VCAT hearing have been provided with a copy of amended plans by the applicant for review. There is sufficient time for Council to form a position on the plans before the hearing starts on 23 November 2020. Officers are currently reviewing the plans and will provide a briefing to Councillors in the near future to confirm the position it will take to the hearing.

8.2 COVID-19 - AMENDED STIMULUS PACKAGE TO SUPPORT BUSINESSES, RESIDENTS & COMMUNITY GROUPS

- notes that a review of the COVID-19 Response and Recovery initiatives approved by Council on 7 April, 9 June 2020 and 1 September has been undertaken and is updated as per Attachment 1 of this agenda item;
- 2. authorises the roll-out of the support initiatives in the Response and Recovery Package as outlined in Attachment 1 to this report; and
- 3. notes the indicative value of initiatives outlined in the COVID-19 Response and Recovery Package is \$8.6m, comprising \$3.4m in the 2019-20 financial year and \$5.2m in the 2020-21 financial year.
- 4. requests officers to investigate options for providing sport and recreation related businesses (such as dance studios) with the opportunity to access suitable public open space for the conduct of their business while COVID Safe restrictions prevent indoor activity. Options must consider Council's need to balance competing community uses (including community access) and be consistent with the intent of Council's Response and Recovery Package outlined in Attachment 1 to this report.
