## Your Memories — Carnegie Swim Centre Photo and video Exhibition

## **Conditions of entry**

Your Memories — Carnegie Swim Centre Photo and video Exhibition ('Exhibition') is being run by Glen Eira City Council ('Council') and will be on display in the Council's Gallery annexe from 23 September to 17 October 2021.

- 1. By entering the *Exhibition*, entrants accept these terms and conditions of entry ('Conditions').
- 2. For eligibility to enter the Exhibition:
- (a) Photographs must be at least 15 years old and of high-resolution (more than 1MB). They can also be scanned copies of photographic prints but should still be more than 1MB.
- (b) video footage must be at least 15 years old. Landscape and in a digital format (MP3,MP4).
- (b) The entrant must have permission from the copyright holder to submit the photograph or video footage if they have not taken it themselves or they do not hold copyright of the photo or video.
- (c) The entrant must submit a valid entry to be determined by Council in its absolute discretion.
- 3. Entrants are permitted to submit up to two (2) photos or videos for the Exhibition. These photos should be submitted as JPEGs, PDfs, PNGs and should be high-resolution (more than 1MB). Video footage must be submitted as landscape and in a digital format (MP3, MP4).

A caption or story (and if possible, date or approximate date) should also accompany each photo or video submitted eg. Jack swimming at Carnegie Swim Centre in 1987. Please provide a maximum of 50 words. The caption (or an edited version of the caption) may be reproduced to accompany the photo as part of the *Exhibition*.

- 4. Council may require entrants to provide proof of parental or guardian's consent to enter the *Exhibition* (if they are under age 18); and proof of age. What is suitable for verification is at Council's absolute discretion.
- 5. To enter the *Exhibition*:
- (a) the entrant must submit a valid application entry online via www.gleneira.vic.gov.au; and
  (b) the entry must be submitted between Tuesday 1
  June and Friday 30 July. Entries outside of these times will not be accepted unless Council extends the submission period, in which case notice will be provided on Council's website; www gleneira.vic.gov.au
- 6. Council will acknowledge receipt of entries by email.

7. Entries chosen to be displayed in the exhibition will be chosen by a panel of Glen Eira Councillors. The Councillor panel reserves the right to disregard photo or video entries which they deem in their discretion to be offensive or discriminatory or which do not meet community standards.8. Not all entries are guaranteed to be displayed in the *Exhibition*. All photo and video entries included in the *Exhibition* are at the absolute discretion of the Councillor panel.

The Councillor panel decisions are final and no correspondence will be entered into.

- 9. Entries must not include personal information (including images within photographs) that would or could identify a living person without the written consent of that person. Captions that accompany photographs or videos should only ever note a first name if required. Only the entry form is to include the entrant's personal information.
- 10. All entrants consent and agree to Council displaying, publishing, reproducing (in whole or in part) and/or using any entries in its public spaces, on its website, on social media, in print media, to perform at the launch of the Photography and Video *Exhibition* and for the future promotion of the *Exhibition*.
- 11. Council is not liable for late, lost, incomplete, invalid or incorrectly submitted entries, or illegible, corrupted or misdirected entries, claims or correspondence due to error, omission, alteration, tampering, deletion, theft, destruction, transmission interruption and communications failure or otherwise.
- 12 The reproduction of an entrant's photo as produced for the Exhibition will be available for entrants to pick up at the Glen Eira City Council municipal office shortly after the end of *Exhibition* period.

## 13 Privacy

The personal information requested in your entry form and as part of your submission is required primarily to enable you to participate in the *Exhibition*, and subject to Clause 3will only be shared with those responsible for organising and conducting the *Exhibition*.
