10.5 Written public questions to Council

1. Peter Vadiveloo

Dear Councillors.

I applaud your production of the 'Our Climate Emergency Response Strategy 2021–2025' and its 6 clear goals. CO2 emissions will ultimately have terrible effects on the health and quality of life of GE residents.

Many residents look forward to seeing its immediate and swift implementation so we can avoid the horrors of what is currently happening in Northern America now, and a repeat of our bushfires in 2019/20.

My question relates to the expression 'net zero emissions'. In in order to determine this value, one has to calculate both 'total CO2 emission' and 'total CO2 absorption'. When these two values are equal, then you have 'net zero emissions'.

So my question is, how is the Council planning to calculate 'total CO2 emissions' and 'total CO2 absorption' (by trees, grass etc) in order to determine if it has reached its target of 'net zero emission'?

Response:

For our Council operations, we plan to seek Climate Active certification from the federal government for reaching our net zero emissions goal in 2024-25. The certification process requires the residual emissions to be offset using eligible offset units that have been verified through a government, private or international standard. These standards ensure that the offset projects are implemented, run and managed properly and the offsets they generate represent real and actual emissions sequestered or avoided. They give confidence that the projects are genuine and credible.

Council has not included an action in *Our Climate Emergency Response Strategy 2021–2025* to calculate the amount of carbon stored in our trees to use towards meeting our net zero emissions target. However, we agree that our trees also play an important role in drawing down carbon from the atmosphere. Unfortunately, there is no recognised methodology or standard for measuring and verifying the carbon sequestration from urban forests that can be used as part of the Climate Active certification process. We therefore cannot use these sequestered emissions as part of our net zero emissions or 'carbon neutral' claim.

There are other councils exploring local carbon sequestration opportunities to offset residual emissions, however they are generally located in regional or outer metropolitan areas, where there is greater access to land and opportunity to increase tree planting for sequestration purposes. We will be watching their progress closely, and if their approach can be replicated in a more urban environment we will consider this in future years, for measuring both council and community emissions.

2. Leila Cusack - Caulfield

A few of the expected impacts of climate change include increased heat, drought and floods, which can, in turn, impact on our health and wellbeing, and affect fundamental city aspects, such as infrastructure, including electricity and transport networks.

Trained environmental specialists could provide useful guidance specifically tailored to the situation in Glen Eira, which is somewhat different to other Metropolitan municipalities, given that Glen Eira has the greatest deficit of open/green spaces and tree canopy, despite being the most densely populated, with an expected population expansion (often in high-rise apartments), which will enhance our need for appropriate environmental considerations. It would seem imperative to be guided by the advice of qualified specialists, utilising evidence, to ensure Glen Eira can be resistant and resilient to future challenges.

We face considerable potential risks. Will plans for Glen Eira be developed based on guidance provided by a professional environmental sustainability organisation?

Response:

Council is committed to ensuring all decisions it makes are informed by evidence, data and contemporary expertise. While we ensure our own staff have the appropriate skills and knowledge for their areas of accountability, we often engage specialist experts to ensure we have access to the best information and expertise available.

This approach is taken across Council, not only for strategies and plans related to environmental sustainability. This is evident in the development of two recent strategies; *Our Climate Emergency Response Strategy 2021-2025* and *Urban Forest Strategy*.

3. Warren Green - Bentleigh

a) After extensive representation from residents and a lack of action from Council, in 2015, the Planning Minister directed Council to undertake its statutory requirement and complete a Planning Scheme Review. At the time, the Minister advised that (quote), "I am concerned that Glen Eira's strategic planning policy framework may not be providing adequate guidance in relation to development within Glen Eira's activity centres" (unquote) and (quote) "I would like to see this review focus heavily on the adequacy of the planning provisions for its activity centres" (unquote). Some six years later, unlike surrounding municipalities, Glen Eira still doesn't have any structure plans, permanent height controls in activity centres or a housing strategy. Given this history, including well in-excess of six years of advocacy, this is just not good enough.

Can the CEO please explain why these fundamental planning controls have not yet been implemented in Glen Eira?

b) Over the last six years, myself and others have been strongly advocating for the implementation of appropriate planning controls in Glen Eira. We have been seeking what is reasonable with outcomes that are consistent with a balanced approach between growth, sustainability and liveability. It's fair to say we have been surprised by the lack of support, advocacy, collaboration and genuine engagement by Council on this topic. Unsure why this is the case as Glen Eira is a unique municipality with evidence indicating a relatively high population density, an abundant amount of future new dwelling opportunities, very low provision of open space, low tree canopy cover and poor planning controls. It has also been pulling its weight with population growth.

Can the CEO please advise how and where this evidence about Glen Eira is being represented as background to the development of the long-overdue Housing Strategy?

Responses:

a) Thank you for your question. Council has three Structure Plans for its major activity centres in Bentleigh, Carnegie and Elsternwick with two more underway for Glen Huntly and Caulfield. The Structure Plans help guide land use outcomes and set the policy direction for housing, jobs and our activity centres. Structure plans present more than just planning controls, they present opportunities for public realm and open space improvements, some of which are currently being realised with the imminent construction of Eat Street in Bentleigh.

Securing planning controls is a planning objective of any Structure Plan but this takes time and can often require additional work to support the technical changes to the planning scheme. With adoption of Council's three structure plans, it allowed us to secure interim height controls which protect these centres while detailed permanent controls are being prepared.

The focus now is to develop a robust housing strategy to support the implementation of our current and future structure plans. This will result in securing the planning controls you desire.

b) Evidence to support the new draft housing strategy will include a demographic analysis and projections, land capacity analysis and likely uptake and neighbourhood character assessments which will consider landscape considerations in addition to built character.

The housing strategy is being prepared in accordance with the relevant Planning Practice Notes as required by State Government. The supporting information gained through the analysis and community consultation will be released with the draft housing strategy so it will be clear how the research has informed the recommendations

The community will be invited to review and comment on the draft before Council formally considers the strategy in June next year. We encourage you to participate in this first round of consultation to provide any further thoughts on future housing in Glen Eira.
