

# Terms and Conditions for Participation in the Golden Ticket Competition

## **Background**

This Golden Ticket Competition (**Competition**) is run by Glen Eira City Council (**Council**), in conjunction with participating schools in the Glen Eira municipality, to promote the Active Schools – Go for Gold Program (**Program**). Participation in the Competition and Program is subject to the terms and conditions set out below.

## **Eligibility**

- 1. A person is eligible to enter into the Competition if:
  - (a) enrolled as a student in a participating school between Monday 4 October and Friday 29 October 2021 (**Competition Term**); and
  - (b) not an immediate family member of:
    - (i.) a Councillor of Glen Eira City Council; or
    - (ii.) an employee of Glen Eira City Council.

## Competition and Prize

- 2. Before the Competition Term, a Golden Ticket (**Ticket**) will be made available to all eligible persons by their participating school.
- 3. To enter into the Competition, during the Competition Term, an eligible person must:
  - (a) if attending school, complete at least 10 (ten) activities to or from school during the Competition Term and have their parent or guardian tick once where indicated on the Ticket for each time they walk, ride or scoot to or from school; or
  - (b) if in a remote learning environment, complete at least 10 (ten) physical activities at home during the Competition Term and have their parent or guardian tick once where indicated on the Ticket for each physical activity they complete at home; or
  - (c) if both attending school and in a remote learning environment during the Competition Term, complete at least 10 (ten) of any combination of the following:
    - a. when attending school, for each activity to or from school during the Competition Term, have their parent or guardian tick once where indicated on the Ticket for each time they walk, ride or scoot to or from school; and
    - b. when in a remote learning environment, for each physical activity at home during the Competition Term, have their parent or guardian tick once where indicated on the Ticket for each physical activity they complete at home.
  - (d) have their parent or guardian submit their entry online via www.gleneira.vic.gov.au/golden-ticket by 11:59 pm on Sunday 7 November 2021.
- 4. An entry must comply with the conditions in clause 3 to be validly submitted.

- 5. Except as otherwise requested by the school, all valid entries will be entered into a draw to win a Fitbit Ace or similar device worth \$99.00 (**Prize**). There will be a separate draw for each participating school.
- 6. The winner from each participating school will be drawn by Council staff at 2:00 pm on Wednesday 10 November 2021 at Glen Eira Town Hall. Council will notify each school of the Prize winners by 5:00 pm on Friday 12 November 2021. Each participating school is responsible for notifying their Prize winner (and, if appropriate, their parent or guardian) in writing and presenting the Prize to the Prize winner no later than Friday 3 December 2021.
- 7. The name of each Prize winner and their school may be published on Council's website (www.gleneira.vic.gov.au) between 12 November and 17 December 2021.
- 8. If the Prize winner for a participating school is unable to attend the Assembly at which the Prize is to be presented, the school is responsible for ensuring that the Prize is given to the Prize winner as soon as practicable after that Assembly. If despite best endeavours, a participating school is unable to contact the Prize winner within 28 days of the draw, then the Prize will be deemed unclaimed, and Council may hold a further draw to award the unclaimed Prize at its absolute discretion.
- 9. In addition to the Prize draw described above, Council provides an additional trophy for the participating school, which achieves the highest activity rate per enrolled student during the Competition Term. Regardless of whether a Prize draw is conducted for a particular school, that school may submit collected Tickets or online entries to Council to be considered for the trophy.

#### General

- 10. Council's decision is final, and no correspondence will be entered into about the validity of the draw to determine the Prize winner. If there is any dispute about the Prize winner's identity, Council will determine the Prize winner in its absolute discretion.
- 11. The Prize is not transferable, exchangeable or redeemable for cash.
- 12. Council may change the Prize at its absolute discretion for a prize of approximate equal or greater retail value with no legal liability.
- 13. There is a limit of one entry per person to the Competition.
- 14. Council will determine if an entry is eligible at its absolute discretion with no legal liability.
- 15. A valid entry must comply with clause 3 to be eligible for the Competition.
- 16. Council is not liable for late, lost, incomplete, invalid or incorrectly submitted entries, or illegible, corrupted or misdirected entries, claims, or correspondence due to error, omission, alteration, tampering, deletion, theft, destruction, transmission interruption and communications failure or otherwise.

- 17. Council reserves the right to alter or amend these terms and conditions at any time without further recourse to the entrants. No correspondence will be entered into with entrants.
- 18. Council is not liable for any loss, damage or injury whatsoever suffered by an entrant or third party, including but not limited to direct or consequential loss, as a result of entering or participating in the Program including cancelling the Program or in connection with the redemption or use of any Prize.
- 19. If for any reason any aspect of the Competition is not capable of running as planned, including because of tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of Council, Council may, in its absolute discretion, cancel, terminate, modify or suspend the Competition, or invalidate any affected entries.

#### Privacy

- 20. Council collects personal information from entrants to administer this Competition, including announcing and publishing any Prize winners as set out in these terms and conditions.
- 21. Council may also publish images or other content relating to the Competition and the Program on its print and digital publications, including social media. If such publication results in the use or disclosure of personal information other than as contemplated in clause 7, Council will use reasonable endeavours to seek consent from any individual who can be identified.
- 22. Personal information collected through this Competition may be used to research and analyse methods of transport to school within the Glen Eira municipality, and aggregated information about participation in the Competition may be passed on to VicHealth. Council will assess all entries in its Golden Ticket Competition (the Program) to determine the Program winners. Your personal information will not be disclosed to any other external party without your consent unless required or authorised by law.
