## Youth Art Exhibition 2025

Photographic images of artwork must be uploaded in a JPEG format no greater than 20 megabits. Entrants of the *Youth Art Exhibition 2025* (Exhibition) will be published on Youth Services @gleneiraartexpo Instagram account using these images.

## Terms and conditions of entry:

1. Eligibility

(a) Entrants must, live, work or study within the City of Glen Eira.

(b) Entrants must be between five and 25 years old. Entrants under the age of 18 must obtain their parent or guardian's consent by way of signature where indicated below.

Eligibility will be strictly enforced.

2. Entering the Exhibition

(a) Entries will only be accepted via the online registration form within the published dates of open submissions, Monday 2 June 9am to Friday 15 August 5pm.

(b) Entries are limited to one per entrant.

(c) Entries must be the original artwork of the entrant. Any entries considered to be works of plagiarism will not be accepted.

(d) Entries that depict violence, discrimination, sexually explicit or other inappropriate material will not be accepted.

(e) Entries that are generated by Artificial Intelligence (AI) will not be accepted.

(f) Entries must not have previously been awarded a prize in an event or competition held by Glen Eira City Council (Council).

(g) Entrants are solely responsible for the formatting of the entry.

(h) By submitting an entry, all entrants grant to Council a worldwide, fee-free, transferable licence to use their entry for any purpose relating to Council's functions, including by publishing their entry on Council's print and social media. All entrants further consent to any act or omission by Council which would otherwise constitute a breach of their moral rights.

## 3. Other people's rights

(a) If an entry contains another individual's personal information (including their image) or another person's work, it is the entrant's responsibility to seek consent from those individuals. Council may disqualify an entry if it becomes aware that an individual has not consented to their personal information or their work being included in the entry.

4. Exhibition and prizes

(a) Artwork must be submitted at the Glen Eira City Council Gallery (Gallery) at a determined time for the work to be displayed in the Exhibition and considered for prizes as set out in this clause. Artists

are responsible for collecting their artworks once the exhibition period has ended. All artworks not collected from the Gallery by 5pm Sunday 12 October 2025 will be disposed of.

(b) All accepted entries will be exhibited and entrants acknowledged by name at the Gallery. Winners will be exhibited on the Youth Services Instagram Page (@gleneiraartexpo).

(c) At Council's discretion, entries may also be exhibited at a Council premises or on any of Council's internet platforms. The entries will be sorted into categories as follows:

- Category 1: ages five-nine
- Category 2: ages 10–13
- Category 3: ages 14–17
- Category 4: ages 18–25

(d) The winning entry in Category 1 will receive a prize to the value of \$100. The winning entry in Category 2 will receive a prize to the value of \$150. The winning entry in Category 3 will receive a prize to the value of \$250. The winning entry in Category 4 will receive a prize to the value of \$300 and solo exhibition in Gallery Two in 2026.

(e) Council will allocate a Judge with industry experience to determine the winners. Such determination is final, and no correspondence will be entered into.

(f) Winners will be publicly announced during the Presentation Night on Thursday 4 September and via Instagram on Friday 5 September. Names of the winners will be published in *Glen Eira News*, on Instagram and on Council's Youth Services Facebook page.

(g) Winners may not exchange their prizes for money. Council is not responsible for any loss suffered or incurred by any person in connection with or arising from redemption of any prize.

5. General

(a) If for any reason any aspect of the Exhibition or competition is not capable of running as planned, including by reason of tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of Council, Council may in its sole discretion cancel, terminate, modify or suspend the Exhibition or competition, or invalidate any affected entries, if required.

(b) The personal information collected on this form is collected by Glen Eira City Council to administer participation in the *Youth Art Exhibition 2025*. If you do not provide this information, it may not be possible to include your entry in the Exhibition or the competition.
