- Target the five areas in the city plan.
- Putting QR codes around businesses.
- Committee volunteers to promote the survey.
- Reach out to larger businesses in the area for support.

- 2. Survey incentive (prize) to be arranged and promoted with the survey.

- One of the biggest changes hybrid working being the norm.

What is missing for businesses?

- More business coaching and mentoring
- Technology and innovation

- Staff are not going to the City as much which is beneficial for local business.

What was the biggest change businesses had to make, and will that stick in the future?

- Businesses becoming more aware of data/privacy, cyber security and automated processes.
- Businesses have had to transform to work in a digital space and to be able to run a business solely digitally.

How does work from/near home affect your business or your sector?

Limits availability of staff to attend in person.

What is the ingredient most needed to have successful business in GE?

- Promotion of businesses.
- Place based search mechanisms it's not always easy to find businesses
