5. WRITTEN PUBLIC QUESTIONS TO COUNCIL

This evening there were two Written Public Questions to Council received.

Laura Carbis	Question 1
Bentleigh East	I remember hearing some time ago that there were plans for the Mackie Road and North Road intersection. What were they, and why are they yet to be implemented? The difficulty in navigating this intersection causes severe traffic problems for Poet Road as commuters prefer the traffic lights of the Poet/North intersection. Will council put in place traffic relief measures for Poet Road?
	Answer:
	The intersection of North Road and Mackie Road falls under the jurisdiction of the Department of Transport and Planning (DTP).
	Council is not aware of any current plans by DTP to upgrade this intersection. Previous advice from DTP has indicated that this location does not rank as highly as other intersections across Victoria in terms of priority for upgrades.
	Nonetheless, Council officers will raise the matter with DTP again to seek an update, and advocate for further investigation into potential improvements at this location.
	Regarding Poet Road, Council's Transport Engineering and Safety team has recently investigated concerns about traffic congestion along the street. As a result, Council is currently seeking feedback from Poet Road property owners on proposed changes to parking arrangements aimed at easing congestion during weekday peak periods.
	We will consider the feedback that we receive before making a decision in the coming weeks.
Natasha Cummins Glen Huntly	Question 2 Our Southern Mahogany gum has grown rapidly over the past 25 years. This species is known to drop limbs and this risk increases as the tree matures. Especially after high winds and storms we, and our neighbours have become increasingly worried. You would not camp
	under this tree yet we sleep under it. We are prepared to borrow the funds to remove the tree because we don't intend to be liable for damage to property or to life. We are unable to maintain the tree due to the enormous ongoing cost to our family and it doesn't ensure the safety of the people who live and sleep beneath it, especially given the effects of climate change and the unpredictable nature of this species.

If a tree removal permit is not granted, how will issues related to maintenance and liability be managed by council?
Answer:
Council is not responsible for the maintenance of trees on private land and, unfortunately, we are unable to provide you with legal advice. If you have any queries relating to liability, we suggest that you seek independent legal advice.

- 7. Notwithstanding the present intention to sell the land to the owners of 63 Downshire Road and 54 Shoobra Road in Elsternwick, in the event that submissions are received from other adjoining property owners or interested parties, Council reserves the right to sell the land to any other interested property owners.
